One of Tanzania's greatest long-term development challenges has been providing citizens with access to decent and affordable housing. Despite rapid urbanization and an increased demand for affordable housing and housing finance, interventions by the government were having limited success. Many lower and middle-income families in Tanzania were forced to spend years living in poor or unfinished houses or renting with little hope of saving enough money to build or buy their own home.

Access to affordable housing can have a big impact on a person's well-being. A safe, secure home can improve health, hygiene, and educational opportunities by ensuring access to clean water, safe toilets, electricity, and a respite from heat and disease-spreading insects.

According to the 2022 population and housing census results, Tanzania's population increased by 37% between 2012 and 2022. More than six in 10 people live in the rural areas in houses built with locally available materials such as mud and poles or sun-dried earth blocks for wall and earth, sand or dung for floor, with grass thatch roofs. The urban population is growing at a rate of 5.3% per annum, higher than the national population rate of 3.2%. Major cities such as Dar es salaam, Morogoro, Mbeya, Arusha, Tanga and Dodoma draw people in search of work. The census results also showed a total of 739,285 houses were at various stages of construction but households started living there due to a scarcity of housing.

Having to acquire land titles, building permits and mortgage finance are seen as obstacles to affordable homes for Tanzanians. Due to inadequate delivery of housing, there is extensive development of slums and informal settlements.

The housing shortage throughout Tanzania is considered to be around 3,000,000 units and this is increasing by about 200,000 units per annum.




WALKABLE NEIGHBOURHOODS:

The Prince of Wales, in his book, Harmony - a new way of look at our world, outlines the concepts of **Fibonacci layouts** for living communities, villages and towns.

He has demonstrated the principles of 'sustainable' urbanism which can add social and environmental value to towns and cityscapes through mixed-use development, by placing the pedestrian at the centre of the design process, by emphasizing local identity and character and by use of ecological building techniques.

'Poundbury is an attempt to create a fully liveable settlement based on traditional approaches, and to do this in a way that truly meets modern challenges, for example reducing reliance on dwindling supplies of oil and building the social capital that is so important for our collective well-being.' P.240 Harmony

Poundbury comprises high-density, mixed-use buildings; workshops, offices, local services, private housing and social housing – even factories – are all placed next to each other. There are no zones. This master plan was one that the community itself had helped to create and it set out a town plan that was inspired by approaches to urban layout that pre-dated cheap oil and cars. One of the main principles was that Poundbury should be a 'walkable town'. That is to say, most daily needs should be within a tenminute walk.

This is the way nearly all villages and market towns are found to have developed. They would often begin by being a settlement on a crossroads. Over time the settlement would expand, but it is fascinating that, in so many cases – often until the advent of the motor car – the expansion of many settlements was always limited by the distance people were naturally prepared to walk. The walkable distance is the one that dictated the spiral-like basis of Poundbury's layout.

The determination not to put the car at the centre of things also influenced the design of the street plan, to the extent that in many places there is not so much a road as a space. It is the buildings that define these spaces rather than a road layout that dictates where the buildings appear. So there are moments in the design process when what seems like a road suddenly opens out into a square, sometimes wide, sometimes narrow. This is exactly the opposite of what happens in every other conventional, Modernist development.

Also, a rule closely observed is to make sure that there is always some sort of structural 'event' at regular intervals. It could be a fountain, a tree or a bench, but the combination of this varying shape to the roadways and surprise events results in drivers naturally going slowly. There are no traffic signs nor any white lines painted on the ground – such natural traffic-calming measures built into the design help to prevent accidents involving a pedestrian and a vehicle.

Most house fronts connect directly with the thoroughfares and public spaces which are laid out so as to maximise the flow of pedestrians. High-quality materials, locally familiar designs and the use of craftspeople rather than prefabricated units confer on Poundbury qualities of authenticity and local character. The localist philosophy has also helped to retain and expand the local skills base in traditional building methods.


A calibration increase of 1 point is in fact a 10 fold increase in energy.


The soul does it all. The soul is a duplex, two personalities being manifested into the physical by our soul.




Childhood Suppression






SPIRIT BODY Brennan Model of the 7 Levels of the Human Energy Field




The pain from ANY illness will not exceed the pain experienced during our Childhood Suppression!






VILLAGE RAISING of a CHILD vs Corporate CHILD CARE

Governments may perceive that income generated (and their taxes) by parents while having their children ensconced in a corporate child care centre is beneficial for the nation. Please consider this:

- The child and children, when at child care centres, are being deprived of their direct interaction with a parent or both parents in the time of its life it needs them the most.
- Ask yourself, who hurt me the most when I was a child? Being abandoned is life long harm.
- Being abandoned is a crisis for a child that NEVER heals! Five minutes lost in a supermarket barely matches the trauma of being left all day amongst strangers at a child care centre.
- We say, the child will get over it we even tell the child to get over it! It does not and WE do not.
- By suppressing the child's personality we are entombing it into a lifetime of trauma. We brush all this off because that is what our own parents did. Our life long dramas are consequently repeated by the child in its adult life. We are fixing our children to never ending treadmills of our making.
- Until we personally begin to heal ourselves of our own childhood suppression then we are ensuring our errors and injuries are absorbed and repeated by our own children.
- We are to express our feelings both good and bad. Yet we ignore our children when they wish to talk and express their feelings. Many of us were told to be seen and not heard.





This time, in the history of humanity, is the most exciting time ever experienced.






PARADISE VILLAGE KEY ELEMENTS:








Somehow, we go on smiling and laughing...


Meet Verna, a Nature Spirit, also known as 'Lady of the Lake': "Your spirit is your own unique spirit

John: What happens to the spirit bodies of such animals, including fish?



Checking out at the store, the young cashier suggested to the much older lady that she should bring her own grocery bags, because plastic bags are not good for the environment,.

The woman apologised to the young girl and explained, "We didn't have this 'green thing' back in my earlier days."

The young clerk responded, "That's our problem today. Your generation did not care enough to save our environment for future generations."

The older lady said that she was right our generation didn't have the "green thing" in its day. The older lady went on to explain: Back then, we returned milk bottles, soda bottles and beer bottles to the store. The store sent them back to the plant to be washed and sterilized and refilled, so it could use the same bottles over and over. So they really were recycled.

But we didn't have the "green thing" back in our day. Grocery stores bagged our groceries in brown paper bags that we reused for numerous things. Most memorable besides household garbage bags was the use of brown paper bags as book covers for our school books. This was to ensure that public property

(the books provided for our use by the school) was not defaced by our scribblings. Then we were able to personalize our books on the brown paper bags.

But, too bad we didn't do the "green thing" back then. We walked up stairs because we didn't have an escalator in every store and office building. We drank from a fountain when we were thirsty instead of using a cup or a plastic bottle every time we had a drink of water. We refilled writing pens with ink instead of buying a new pen, and we replaced the razor blade in a razor instead of throwing away the whole razor just because the blade got dull. But we didn't have the "green thing" back then.

Back then, people took the streetcar or a bus and kids rode their bikes to school or walked instead of turning their moms into a 24-hour taxi service in the family's US\$45,000 SUV or van, which cost what a whole house did before the "green thing."

We had one electrical outlet in a room, not an entire bank of sockets to power a dozen appliances. And we didn't need a computerized gadget to receive a signal beamed from satellites 23,000 miles out in space in order to find the nearest burger joint.





Large average household sizes—five or more persons per household—are observed across much of Africa and the Middle East.




