#### **PRACTICES of the PAST and CURRENT are to END!**

#### Some simple experiences with remote and isolated Aboriginal communities.

Dean Rowley: Where do I start!

How many pages do I need to explain my experiences and observations without inflaming viewpoints by over simplifying?

The following are just some of the key issues that I have personally observed.

For the past 30 years I have had the pleasure of working together with Aboriginal & Torres Strait Islanders in remote and isolated communities from north west NSW, Queensland and the Torres Straits.

My involvement has been limited, challenging, frustrating and yet extremely rewarding and I have learnt far more than I ever expected. Initially engaged

by the Government as a Grant Controller for an isolated community to manage funds for a few months until all projects could be shut down and funding discontinued because of previous financial management issues.

I very quickly had to dismount from my "white horse" (with its security blanket of ignorance) when it soon became apparent that far from the community failing it had essentially been forced to surrender its community spirit and expertise along with all local management to the funding bureaucracy.

Unfortunately I *failed* in this first engagement, as contrary to the terms of my engagement, financial management issues were addressed readily by the community, funding was secured for the community, funding was increased, operations expanded and led to the initiatives developed being implemented across Australia.

Unfortunately this initial experience was only to be my first exposure to challenges that are still ongoing.

#### Warning – all of the following examples are still happening today unfortunately!

- Housing
- Education
- Community Elders
- Government Contracts
- Accountability



**Housing** – with a contract to build new homes in an isolated community, with the typical occupancy of anywhere from 10-15 people, I thought relief was being provided until the wheels of government assistance came to the fore and proved otherwise. Architects were flown from Sydney, government regional housing officers flew in charted aircraft to meet with the community, the scarce community resources had to provide vehicles, staff and costs of the 720klm pickups and then in a carefully orchestrated meeting the incoming tenants were asked to immediately accept and approve the

construction plans thrust upon them. When challenged regarding the suitability of the plans presented i.e. some basic questions as to why a timber high-set home with veranda's front and back only had one internal staircase (obvious fire risk with very large percentage of occupants smoking), why with 10 plus occupants was there only one toilet and that was within the bathroom, why there was no laundry / separate toilet downstairs, why was there no provision for flow through ventilation in a north western NSW home etc. etc. the reply was stunning – "these are the standard plans, that's what you get".



The cost of this single meeting alone would have provided additional bedrooms and separate toilets, etc.

How are the incoming residents and the community, the beneficiaries of this much needed housing, able to stand up to the government and say no thanks you are not treating us as equals?

**Education** – country schools are sincere in their quest to provide education but local management in their quest for success (maybe then a teacher transfer to the coast?) really works hard at encouraging Indigenous participation, got to keep the numbers up!

A school bus runs to the isolated communities but don't worry if you miss that bus we have a backup bus following later, and if you are still sleeping in don't worry we will then send an Aboriginal Liaison Officer, and car, to your door to see if we can rouse you from your slumber! Don't worry about being late for school we will still have time to give you a biscuit when we get there!!!

School management are justly proud of their daily logistical prowess but an observer could see this as failing the kids, failing the broader community by applying two different standards to attendees and not developing motivation and enthusiasm for education with the kids. Of course the "sleepy" kids see this as a pathway offering lowered standards that can be used throughout their education journey.

The culmination of this oft repeated scenario could of course be what the Batchelor Institute in the Northern Territory has been racked in controversy for. Maintaining pass rates for Indigenous students to ensure ongoing funding for the institution has been described as *"the soft racism of low expectations"*.

Communities have many young single mothers, very few of these have learnt cooking and nutrition skills, many educational projects have failed in the past. The approach that did work was <u>not</u> to teach the young mums to cook but to <u>help them</u> to cook for their elders "meals on wheels-by the

community-within the community". Simple but very, very effective with generational outcomes.

**Community Elders** – a difficult discussion.

Elders are respected within their communities but communities are based on family connections, discussion and consensus. The need for the government "fly in-fly out" problem solvers to have a signatory to verify their discussions, plans, contracts, etc. seems to have elevated the status and powers, of an elder to meet government obligations.

A cynic could claim that the concept, and elevation, of elder's was simply that they were reasonably accessible i.e. remained within their communities due to failing health and lack of travel resources etc. and are passive when presented with funding opportunities that need to be signed here and now with the threat of the opportunity being given elsewhere.

The communities do respect their elders but this concept of elder's signing contracts without the opportunity for community consultation is regarded as disrespectful.

**Government Contracts** – this has, and continues to be, a very difficult realignment of my beliefs that a contract is valid unless of course the government says that contract is now not a contract. Some of the cases that I have personally experienced as a signatory (for many millions of dollars) were beyond any possible comprehension of mine that the bureaucracy could behave that way.

Construction contracts, road works contracts with local government, water and sewerage contracts, language revival contracts, plant and equipment contracts, community funding packages etc. etc. have all been subject to requests (demands is a more accurate term) from the government to cancel existing contracts to meet the needs to balance department or State budgets and of course backed up with "trust us we will issue new contracts for you at the start of the new fiscal period".

If cancelling contracts is required to balance the books then maybe the departments themselves should consider their own accountability standards instead of the subterfuge offered up to taxpayers. At the same time the departments are holding the funding recipients accountable to a set of standards that they themselves do not recognise.

Of course in the real world breaking contracts is legally challenging, expensive and creates mistrust between all parties that will be a remaining legacy to the communities' detriment.

Breaking construction contracts incurs additional holding and re-commencement costs, breaking water and sewerage contracts incurs additional construction and health costs to the community, breaking road construction contracts can lead to a delay of several years getting the required specialised plant and equipment back into the region and can cost lives on unsafe roads, etc. etc.

#### The Golden rule is: Never interfere with another's will.

**Accountability** – We have all seen the vehicle graveyards in the outskirts of isolated communities, how many viewers of these scenes appreciate that government funded vehicles are replaced, i.e. a Troopie is replaced with a new Troopie, not limited to funding the difference between a trade-in and a new vehicle (too difficult the bureaucrats claim)!

The community have learnt from this and they have become very skilled at swapping engines, running gear, body panels, etc. and making trailers from chassis, etc. The other skill they have learnt is not

to respect assets as they will be replaced from the heavens (or taxpayers)!

When we first started challenging the community accountability issues the response was simply a blame game, blame the co-ordinator, blame the department, blame the white man, etc. however once you start on a specific community service that has a problem and can break down the financials for that service the community quickly takes ownership and uses its own resources to maintain the service.

Within a few months (and not without hiccups and serious headaches in those months) we were then responding to department enquiries questioning why expenses had dropped so much and across the board. I found that interesting as the out of control expenses was the rational for the government had engaged me in a caretaking role for the winding up. Of course all that had changed was that the community took ownership of the expenses, not an external bookkeeper, but that is not an acceptable explanation so we had to simplify our explanation to the simplest possible that we could think of which was then readily accepted (although totally nonsensical).

There seems to be two main categories of accountability applied to Aboriginal community funding, unfortunately I am still today seeing examples of this and they still disturb me as much as they did when I first confronted this issue.

If a grant of say a AU\$150,000 is stolen by a key person in the beneficiary organisation and this theft is reported to the funding body in almost all cases the funding body will say "thank you there is nothing further we can do, please re-apply next year" i.e. no financial acquittal of funds is required as that would only draw attention to the loss and maybe embarrass the department.

However if an acquittal of say a AU\$150,000 grant is not quite 100% accurate an Aboriginal organisation is either:

- a) Hauled over the coals until the minor discrepancy is corrected; or
- b) Departmental assistance is provided to help cover up the discrepancy (without asking any embarrassing questions).

I have even seen a rare case of a Police conviction for funding theft without the funder even interested in action or recovery.

Balancing these dubious standards that I have personally observed with Indigenous community accountability is the laughable experience in the opposite extreme that I have confronted where I have been asked to conduct a series of business workshops across regional Queensland, Australia (which I love doing).

The accountability catch was that I could only be paid if I found a JP (Justice of the Peace) in each regional town to sign my attendance sheet. When I explained that this might not be as easy as it seems in finding a JP in Brisbane, that is not always possible in regional areas due to road closures, floods, funerals, etc. etc. but how about I provide a date and time stamped local fuel receipt, and/or, even more meaningful, an attendance register of the workshop with names, signatures and contact details that could also be used to verify that the workshop held was meaningful and productive.

Unfortunately these accountability options offered were not deemed suitable and therefore the workshops did not proceed.

I once spent twelve months arguing with a Federal Government department that I only wanted the requested AU\$300,000 for an Indigenous employment project and not the AU\$600,000 that they

offered by contract. The additional AU\$300,000 was added by some unknown department employee who decided that I needed to have paid Indigenous mentors whereas I believed the strength of the mentoring was that it was being done for good, not for dollars. I eventually won this battle and received the AU\$300,000 requested and the project has gone on to deliver over 20,000 Indigenous career placements over 30 years. Without the support, and belief, of the local government I would not have been able to personally bring this to the attention of the Federal Minister and get what I believed would work, and it did!

#### Overview

As an outsider entering into a whole new world, engaged by the government, I thought in my innocence that I could offer something, I was briefed that the community was the challenge but was quickly confronted with the realisation that there was a far bigger challenge to be faced.

We won the battles for the housing construction, for the contract cancellations, for the accountability requirements, etc. and the way these were done is not what is being taught in management school or accounting but they worked and they bought the community some good outcomes and confidence in themselves and their own abilities.

The manoeuvres used to circumvent these issues also provided a good laugh along the way even if they seemed like a Monty Python skit!

If you have come here to help us – you can leave now. If you have come here to listen and help us to solve our problems – you are welcome.

# Environmental Collaboration ENVIRONMENTAL CONFRONTATION

Verna, a Nature Spirit, 26 May 2019: You believe people like your Australian Aborigines were more in touch with nature because they didn't seemingly destroy it as much as the white man invaders have done, however they weren't, not spiritually speaking. They hunted and gathered and did a minimal amount of farming, but they still didn't understand about our connection with the World, they didn't personally interact with us, they developed their own wayward spiritual beliefs and ceremonies all designed to keep them fully entrenched within the Rebellion in a more primitive way, and it was all still wrong by higher spiritual standards. So the aboriginal culture had to go, just as in the end so will the white man culture, as people of all races who do their Healing and who do work more closely with us nature spirits will end up doing. But that's still some way off and there's a lot of spiritual awareness awakening that needs to happen first.

So in one way it seems like the aborigines were closer to nature and the natural world, which they were in their more primitiveness, whereas they weren't in a spiritual sense. And so shouldn't be held in higher regard. They can of course be appreciated like all spiritual and religious beliefs for being an expression of truth-denial and the Rebellion, should one want to appreciate such wayward beliefs.

Helen, 3<sup>rd</sup> Celestial Heaven, 27 August 2017: You have **the Eastern mind controlling Buddhists doing their bit from long ago, which was a remnant surviving from the Atlantean age,** along with the other primitive and spiritual systems of belief, and now it's all coming to a head for we are arriving at the end of the next Earth age, with The Change, the next cataclysmic event not far away in Earth natural time.
