




## Conduits, Gogs & Wheels

### ASSEMBLE


There is this great realisation of decades of work by a few however involving many that is for the benefit of all of Earth's humanity.

Nation and state, benefitting the government of the country, requiring Public Private Partnership agreement in support of what is agreed to be delivered.


Community and regional projects with the local people driving and delivery the agreed projects all being in compliance with government regulations at all levels.

Major infrastructure projects will always require government involved.






**PROFOUND REVELATIONS**




Yes, we are continually told to look up there when we should be looking down here! We have proven to be very submissive – easily misled!



**SOUL LIGHT emitted is to be BALANCED by the LIGHT RETURNED!**


**Two separate personalities on parallel 'circuits' having the same soul.**

### **Dr Abigail Marsh's Blog of March 2022 – observations by Samantha McCabe**

20 October 2022

I have listened to the audio with Dr. Abigail Marsh and feel very sad for the children and adults who have these Psychopathic tendencies, I feel very hopeless for them because the professionals that are trying to help them are not truly on their side but on the side of the parents. They are not seeing the helpless children that these people once were because they won't accept that it is wholly because of the way they were parented, they won't blame the parents so who do they blame then!! It must be the child. These children have been completely desensitised from their emotions from a very young age and cannot feel fear, empathy, sadness or love for anything and this can only come from being desensitised from these emotions in early childhood by their parents, they weren't just born like it, they weren't just born bad, they learnt to be like it by their unloving, uncaring, un-empathetic parents, it is that simple and if these professionals stopped avoiding it and stopped protecting the parents, the truth would be easily seen as to why these people are the way they are.

The interview goes on to say that it is highly difficult for the parents of these children and how do we help the parents deal with this!! It is all about helping the parents deal with this awful naughty child that won't behave and be how the parents want the child to be. This is all about making it easier for the parent who can't figure out why their child is such a disappointment, so unruly. The professionals are backing the parents in this so how does the child have any chance when even the professionals are on the side of the parent and the child is the problem. The problem has to be with the parents and their parenting. The parents have to be confronted and the professionals won't do this.

**Dr Abigail even says it in this interview "The most effective treatments tend to be some combination of training aimed at how parents respond to their children. And I say this with caution because it's too easy for people to assume that if you are addressing parents' behaviour to help treat the condition, that it's the parents' behaviour that caused the condition. And I think that's a huge myth I'd like to dispel. We know that behavioural therapy, a lot of it administered by parents is a really effective treatment for children with autism. You have to use very specific kinds of interpersonal behaviours to help them develop. But we don't think that parents cause autism, or at least not anymore, right? We used to think that. This used to be just accepted wisdom in psychology that refrigerator mothers cause their children's autism. Unfortunately, we're still in that place with psychopathy where a lot of people assume it's the parents' behaviour that causes it."**

I feel that these Psychologists won't put the blame on the parents because they were not allowed to put the blame on their own parents, they are still not allowed to think of their own parents as being wrong and confronting their own parents with the results of their unloving parenting and the affects it has had on them as adults. It is like upsetting our parents is the biggest sin but if Psychotherapists have this issue still within them then the roots of these disorders will never be found because the professionals will not confront the parents because they couldn't confront their own parents. If you want to know why a child is

the way it is, then psychotherapy has to begin with the parents. The first course of therapy has to be aimed at the parents and they have to be confronted with the truth of their own childhoods to find out why the child is the way it is. We have to stop trying to spare the parent the blame, we have to stop pandering to the parents, it is like spare the parents and blame the child and it is all wrong. The child has been taught to be this way right from conception and its teachers were its parents.

I know this interview with Dr Abigail Marsh gives the impression that the child is important but when I listened to the Audio, I felt that this isn't the case and too much importance has been given to not blaming the parents, to me, they are 100% to blame for a ruined child who grows up to be a ruined adult. We all have to confront our denied and suppressed childhood feelings to end this hell loop we are all living of passing on our pain to our children. We all have severe psychological disorders and are prisoners until we allow the release of our denied and suppressed childhood feelings, we will never be free until we confront this within us all.

The interview goes on to say that these psychopathic children are fearless and have never felt afraid of anything and don't respond to punishment through fear and all of that has to be felt through. Why don't they feel fear, are they using the lack of fear as a source of regaining the power that their parents took from them continuously as young children, is their lack of fear their superpower against their parents, are they so terrified as children that they no longer allow themselves to feel fear as a defence mechanism, has fear been so denied and suppressed inside of them that they block it all out so they are now numb to it?

The truth of this fearlessness has to be known and it will only be known through the feelings of the child involved, and it will be a terrifying process to bring all of that terror out, to accept it, to express it and to finally know the truth of it and where it originated, and its origins will be in its early childhood at the hands of its parents.

Huge resources don't need to be thrown at this; just the right communication needs to be given to the child. The child was a helpless little child with no one to talk to, no emotional support and this is what is needed, the right communication and for its feelings to be taken very seriously indeed by its therapist but if the therapist hasn't taken their own feelings seriously about their own childhood denied and suppressed feelings, then how are they able to help a child with the right communication. Medication is not the right communication, this is just more denial of the child's feelings, more of letting the child know that there is no hope for it so let's just medicate it away, this is what they did to me when they told me I had psychosis as a late teenager and I felt hopeless, like even the professionals didn't know what to do with me and it makes you feel like ending it all. **The right way to tackle this is with the right communication, the communication of the feelings and what they are telling the child, I would have felt such a relief to have been listened too!**

The interview says they are focusing on new and more effective treatments of Psychopathy including brain imaging and I feel that this is all so mind driven, and that of course is what drives the medical professionals in their research but for me it is all such a waste of resources. This isn't about the mind leading the way, this is about the feelings leading the way and telling us the truth about how we feel and expressing that. A brain scan can never do that, our feelings are more advanced than any piece of technology available or that will ever be discovered. The feelings will tell us the truth about how we feel and that is never wrong, all it takes is the right communication and someone willing to ask the questions and then just listen, the listening part being the most important because these children haven't been listened to, just told that they are broken and wrong.

Dr. Abigail Marsh says that at least 50% of every psychological phenomena is heritable and the same goes for Psychopathy but throughout my healing I can trace all of my pain (pain I use as the word to describe a whole umbrella of feelings) back to my childhood and the way I was parented, so I have to disagree with 50% and for me **it is 100%**. It is still like the medical professionals don't want to 100% blame the parents for a child's psychological disorders and it makes them feel better to put it down to 50% heritable, and what a nice way to put it, 'Heritable' not blaming the parents and the family lineage, sparing the parents the guilt of what they have done to their child, still on the parents side when I say "You, the parents, and that includes me as I am a parent, are 100% to blame for fucking up your child and now deal with it and what you have done to them".

We have to confront the pain that our unloving parents caused us, we have to confront our childhood, and that means our parents will have to do this eventually too. If we don't then our denied childhood experiences become the compulsions and addictions in our adult lives and get twisted and contorted into all manner of psychological traumas that we become a prisoner to. All of this pain needs to be released by the accepting, expressing and the truth of our denied and suppressed childhood feelings being known and no technology can do this for us, we don't even need it. What we need is to be heard, seen and our feelings taken seriously by our parents. If children have no empathy, that's because they weren't shown any empathy from their parents, if a child doesn't show any care, it's because it wasn't shown any care by its parents, if a child wants to hurt and kill, it's because it was hurt and wanted to be killed by its parents, if a child shows no remorse, it's because its parents showed no remorse for the way they treated their child, if a child is insensitive to the pain it has caused, it's because the parents showed no sensitivity to the pain they caused the child, if a child shows no fear, it is because it was so terrified as a child and not allowed to express its fear, it is numb to the feelings of fear because it had to be to save its own life as a child with its parents.

Dr. Abigail says she wants to know more about understanding the human psychological behaviour, for this she will have to go to the feelings and let them tell her the truth, she will have to listen and really desire to know the truth of how her patients are feeling to understand them more and this is the only tool she will need.

Just her, her patient and her patients' feelings and the truth will reveal itself without the mind leading the way as it is right now. Let the feelings lead the way and let them reveal everything about her patient. Just listen and let that person begin the journey of healing through their feelings and the discovery will be disturbing of course, but the most amazing revelation she will ever encounter.

She says she is in the middle of pursuing what it is that makes a person truly care about another, but I feel it is impossible to truly care about another without doing your own feeling healing and caring about yourself first and all of this has to be done with the inclusion of God's Divine Love, the relationship has to be with our original parents, the parents of our soul, God. Through our feelings and with the inflow of God's Divine love we will be shown the truth of how we feel about ourselves and others, and it will be nothing like how we thought, all of the lies will be revealed, and we will know that we have been kidding ourselves into thinking that we love ourselves and others.

Dr Abigail also says that our love must come from the original love that parents have for their children, but the truth will also be shown through the truth of the feelings and that the love a parent has for its child isn't true love, if it was true love there would be no pain, no psychological illnesses, no bad feelings, no illness, no murder in the world, all of these bad things come from unloving parenting being passed down to the child. True and real love doesn't do this; love doesn't hurt, kill, cause illness or take the will of

another. **We really have to feel the truth of what we believe love to be and is it right? Our feelings will tell us the truth, not our minds.**

We have all been born into the default setting of our parent's pain and took that on and believed it is the truth, believed it is us, we have no idea who we truly are but through our feelings and the receiving of God's Divine Love we can begin to know ourselves truly and shed the layers of our parent's pain that we have carried around with us all our lives. The pain that we took on in the womb and have let it become our experience. God wants us to know ourselves the way they know us, before our parents got hold of us, and by 'they' I mean God as our Mother and Father, the creator of our souls, our true and loving parents, only they know true love but you can read about Divine Love and more about our Feeling Healing in the PASCAS library.

Parents have done this damage to their children and expect people like Dr Abigail Marsh to take it all away, when really the child is a mirror of the parents level and condition of love, the child is the truth of how it was parented and it is staring the parent in the face every day and the parent hates it, the parent hates what it has created saying it is nothing to do with me why my child is like this, and the parent wants the doctors to fix it, take it away so the parent doesn't have to look at it any more. When we, slowly at first, begin to embrace our feelings, we discover that life is so much easier, that a degree of spontaneity emerges, that difficult things become simple – and we are not back tracking and undoing the messes that we make from accepting our assumptions! Clarity can be found simply.

This will require a total makeover of education systems all over the world. This embraces pre-school, primary school, higher school, technical and further education and all levels and facets of university.

Education is the foundations of any growth and development within any society. Teachers need to become educators, this is not a trade but a profession. Education may need to double in its capabilities, in many countries even treble.

From education comes our nurses and doctors – and all other professions. There are universal shortages and that is the consequence of teachers conditions of employment AND the inadequacy of understanding of what illness and disease is. The doctors suppress the discomforts but there is no curing going on.

When we have investigated the social ills of any country, no matter how wealthy or poor the nation and people may be, certain things stand out:

There is high levels of poverty. Nearly 30% of USA’s population live on incomes below two times what they consider is the poverty line.

One (1) percent of the people control more wealth than 50% of the people. In USA it is 1% of the people that controls the wealth equivalent to 90% of their people.



Democracy has been mostly hijacked. If man has created a system, then man will manipulate that system and democracy is mostly hijacked. Through the ‘respected’ secret societies that are mostly worldwide, we have the hidden controllers funnelling money and instructions through to leadership positions. If they can’t get their nominee into leadership then it is through the second tier operations. Who actually influences the anointment of nominees for election? Who actually influences the writing of party policies, these are not people elected by the people? Parties are formed and policies stipulated and then candidates find themselves being dictated to by these controllers who they never know.

Presidents may be appointed for a fixed or limited number of years. Then watch other members of their family follow in the retiring president’s footsteps. They may call it political family dynasties. It is not the people’s choice.

The overwhelming majority of politicians are unemployable in high level major corporation positions because they do not have the appropriate skills – but they run nations all over the world!

Then you look at the social issues that abound in the country and you find the same old failed remedies being repackaged and applied again only to fail. No one addresses the cause – they don’t even know how to ask; “what is the cause?” More children are being put into prisons all over the world and it is of their parents’ doing – their Childhood Suppression and now their ongoing repression.

What is now available for all societies are the pathways and remedies to begin to address the major social issues within every country. This will require major funding worldwide. This will invariably cause inflation to emerge over time. Inflation can be said to be the devaluing of the currency due to increased supply. An apple always remains an apple but the amount of money available keeps increasing.

As the impoverished are the ones without money, then the value of the cash reserves of the super-wealthy do take a battering which is constructive in shifting wealth out of that sector should the inflationary effects on the poor are addressed during and through the inflationary period(s). Inflation appears to become severe in some regions even before these programs commence due to other circumstances.

## INFLATION

Money is talked about as a constant and that everything else is not. A loaf of bread is constant and so is an apple – money is not, it is printed at the whim of those who own the printing presses.



When I was a young adult, 2 cents could buy what \$1 is needed to pay for today. Inflation (printing of extra money) has reduced the buying power by 98%. Examples:



An imperial gallon of petrol used to cost 20 cents. That is 4.546 litres, a litre of petrol costs AU\$2.20 today and that equates to AU\$10 a gallon. That is a fifty fold diminishment of purchasing power.

A typical packet of 20 cigarettes will now set you back on average around AUD \$40 (£22 / US \$30), which is a hell of a lot of money if you burn through darts like a chimney. A packet of 20 Ardath cigarettes was 20 cents.

A single scoop ice cream in the cone is now AU\$2.79 (Baskin Robbins). As a single scoop was 5 cents then four for 20 cents costs more than AU\$10.

The Sunday papers were 5 cents each and stacked with comics and weekend sport. Now they are around AU\$3.00 each, so four is now more than AU\$10.

We have experienced a 98% drop in the purchasing power of our dollar and we are about to experience a further 98% drop in purchasing power.

Imagine paying AU\$500 for a gallon of petrol!!!

As of a consequence to major disruptions to supply chains around the world due to excessive demand by consumers and Covid-19 and now the Ukraine invasion by Russia, the printing presses of the world have printed a mountain of money for a smaller supply of goods and the consequence is inflation.

Authorities tell us to look up there whereas we need to look not only at our governments BUT the major corporations that are the dominant price gougers. You will find the chain becomes very small, all leads back to a few very obscure and secretive families.

The era of very, very low inflation has ended. Headline inflation in Europe is 7.4% and core inflation 3.5%, way above the ECB's target of 2%. Hong Kong – As inflation soars around the world, the world's second-largest economy has kept it at bay. Consumer prices in China increased just 1.5% in March from a year earlier. The USA Consumer Price Index increased 8.5% for the year ended March 2022, following a rise of 7.9% from February 2021 to February 2022.



## POPULATION GROWTH STABILISATION and DIMINISHMENT

Most of us have lived through an ever growing and expanding economy fuelled by growing populations. Our biggest earning and spending years are in when we are in our 40s. Values of corporations continue to benefit from what investors perceive as ever expanding markets. That is all about to come to an end.

Some nation's populations have peaked and are now aging, thus their internal consumer markets are no longer expanding. There are still many growing population with high growth to come in their consumer markets – but the worldwide phenomenon is beginning to wane.

Over the coming handful of decades, the world's population will peak out and then begin to diminish, however their consumer markets will begin to shrink earlier due to aging of the population.

We are presently a population of 8 billion. This could be the range of the population around 2150. China's population could be then half of what it is today. The population will have a significantly older configuration than what it is today. All of this leads to a devaluation of assets that the super wealthy hold today. Consumerism must revert to a pattern of durable goods – electronic appliances that typically last more than 20 years, etc!

Housing needs to be built to endure extremes of weather and have a long structural life. Thus, housing will need to be just that, long term survival and not an inflationary money box driven up in value due to population growth and its demand that will diminish.

These being drivers shifting wealth back to the many.

# LAW OF COMPENSATION

It's a Universal Law potentially to be 'imposed' upon humanity on Earth. It is currently in 'operation' in the Mansion Worlds, ensuring everyone cooperates in a friendly way with everyone else to maintain a certain standard of life as agreed upon by all involved, that which is determined by the Mind (rebellious) or Truth (Healing) way the spirits might be living.

Currently on Earth in our rebellious states, the Laws of Compensation and Cooperation are not active. So we live with the 'every man for himself' ethic, the powerful being the successful 'winners' who dominate the not so powerful 'failures'. Whereas in the Mansion Worlds (and the rest of non-rebellious Creation), equality, so even in a rebellious state, is the Law, and so if you cross the line inflicting dominance over another causing some level of suffering, pain and hurt, you will instantly come under the workings of the Law of Compensation and have to compensate for such transgression by feeling all that pain, hurt and suffering you have caused the other spirit to feel. So naturally, Universal Law and Order is maintained by everyone honouring the Law of Compensation, no one wanting to bring its 'wrath' down upon themselves.

Then added to keeping the peace, is the Law of Cooperation, for everyone in the Mansion Worlds who are happy and content to further their rebellious mind state in worlds 1, 2, 4 and 6; or doing their Healing, starting in world 1 and moving through 3, 5 and 7. So everyone willingly feels they want to cooperate with everyone else. Therefore, in the rebellious mind worlds, all spirits willingly and 'lovingly' cooperate with all other mind spirits; and the same in the Healing worlds, together with everyone willingly cooperating with the Healing. If you run a business or government that is hurting people economically, socially, emotionally, spiritually, mentally, in any way causing anyone to suffer, then you're going to feel all that pain of all the people you're hurting. Even if you're doing it indirectly. 





South Korea was considered a developing country until the 1960s. Today, South Korea's GDP is about \$2 trillion, and it's one of the most developed and industrialised countries in the world.

South Korea places great importance on education, innovation and investment into research and development. The country has a highly skilled workforce earning a high median household income. Services provide the majority of the country's GDP at 59%, with industry is at 38% and agriculture at 2%.

Revenues from oil, natural gas, and energy drive the Russian economy. Foreign trade is important as the total value of imports and exports is equal to 46.7% of GDP, making Russia one of the top countries by GDP.

Chinese government has done a lot of work to help the poor get rich. I'll give you a few examples:

Poverty had been common in many parts of China, because the traffic is not convenient, so the government emphasises improving the traffic condition as the most important work. For example, in Guizhou Province, one of the poorest province in China, the local government has spent a lot of money to repair a lot of roads. In China, there is a saying, "Building roads is the first step to becoming rich."



The Chinese government has a great plan known as "村村通" (Every village has a highway, electricity, tap water, telephone lines, etc.). Sometimes the investment may seem not worthwhile in economic point of view. I saw a news: in a small village in Xinjiang with only one hundred poor people was asked to move out by the local government, but they didn't want to. So they spend nearly one million

yuan to build roads from the highway nearby to their village, and the government never asked them to move out from then.



In some remote places, there is no electricity nor cable TV, so the Chinese government offers free solar cells and satellite dishes to residents.



The Chinese government has ordered communications companies to build mobile phone signal towers in remote areas regardless of financial benefits. Since these communications companies are state-owned enterprises, they have to execute orders.



In some of the rural areas in China, the government has a great plan called "New Socialist Rural Areas." Houses are built in groups and the government has paid most of the expenses, and the rest is paid by the residents themselves.



There is also a policy called "结对帮扶" (help the poor by collaboration), which means richer areas are assigned to poorer areas in order to help them get out of poverty. In the countryside, every CCP official is required to help a difficult family. The job is very stressful. If his work is done badly, it will be difficult for him to advance, some of them even complain about this.



Sometimes, government officials become a salesman to help farmers sell their products. Look at the picture below. A county market sells watermelons on the street.



The Chinese government also has a policy that sounds very interesting, called "精准扶贫" (targeted anti-poverty projects). It sounds like the policy targets poverty and “destroy” it like Tomahawk missiles.




A large numbers of scientists and agricultural experts are sent to poor areas to research the local environment, figure out what is the most suitable product for them to grow, and guides the local people to grow it.



Since 2011, the Chinese government has implemented the rural compulsory education student nutrition improvement program. The central government has allocated about 16 billion RMB per year to provide food subsidies for rural students. The policy benefits 26 million rural students.



In the past, most rural officials did not have a high diploma. Now the Chinese government encourages college graduates to go to the countryside to serve as officials after graduation. They have a name called "大学生村官" (College students as rural officials). The government hopes their knowledge will help farmers become rich.



In my hometown, poor people can apply for subsidy if his house is not safe to live in. The subsidy is between 5,000 to 20,000 RMB.

There are still a lot of poor families in China, but we see the government trying to improve their lives. But now people have a new topic: in some areas, sympathy because of poverty, the government to give them a lot of benefits, the folk also gave them a lot of money, they don't want to change my life, too lazy to work, so that they can continue to make contributions. Such things are not uncommon.

During the past 30 years, China has helped 800 million people escape poverty, which accounts for 70% of all people lifted out of poverty worldwide. Ban Ki-moon, eighth Secretary-General of the United Nations, recognised China's efforts by saying "China has achieved transformational results in reducing poverty". Many global media outlets also applauded China's achievements in this field.

By the end of 2015, Chinese President Xi Jinping brought up the idea, "eliminating poverty in China by 2020" – 10 years ahead of the target of 'eliminating poverty in all forms by 2030' set by the United Nations.

Today, there are still more than 80 million people living in extreme poverty. The success of Chinese poverty alleviation serves as a valuable experience for the whole world.



Besides personalised anti-poverty plans for each person, the nation's targeted poverty alleviation efforts also include various arrangements to create work opportunities and give people job training, turning the anti-poverty mode from "blood transfusion" to "haematopoiesis."

The Dulong Mountain Valley is home to about 7,000 people in China's mountainous southwest. Due to its high altitude, the mountain is snow-covered for half a year, isolating the community in impoverished and rudimentary conditions.

Different from the usual poverty alleviation, government staff are planning to build the mountainous area as a tourism hotspot with its beautiful landscapes.

Pu Guangrong feels like he's over the moon since government has built new houses for him – two to be exact, one for his family, and another for tourists. Like others in the area, he used to eke out a living by collecting wild fruit and hunting. Tourism wasn't even in his mind, but poverty-alleviation workers changed all that.

Today, his village is connected to the outside world by a new tunnel, luring in tourists, broadening their vision and bringing in economic revival.

A Chinese saying goes, **"Teach a man how to fish, rather than give him a fish."**



But targeted poverty alleviation is more than this. The Chinese government would prepare accommodations and jobs in other places for those who live in areas without development value and encourage them to move away from their original places. As for eco-logical preservation area where exploitation is not allowed, the government will arrange jobs for forest rangers and forest planting. Accordingly, the environment will remain protected while people can have jobs.

In the past five years, the Chinese government has invested 196.1 billion yuan in poverty alleviation and allocated petty loans – 283.3 billion yuan to poor people. (7.2 Chines Yuan to 1 USD)

All positive results reflect on the government's efforts and investment into poverty alleviation. The government officials are encouraged to try their best to implement poverty-alleviation programs. To prevent counterfeiting, the Central Committee of the Communist Party of China has set up a strict inspection system, which allows different provinces to supervise each other, while all data needs to be verified by a third party as well.

Kim Hoonae, director of International Fund for Agricultural Development's Asia Pacific Division, has praised China. "This anti-poverty policy based on the accountability assessment is very effective. The more effort you put into it, the more support you get from government. As a result, local governments are working under pressure while feeling inspired at the same time."

Chinese President Xi Jinping has visited nearly all 14 officially designated 'areas of destitution'. During his entire five-year span at the leadership helm, he has visited poor regions even on the eve of every Lunar Chinese New Year – Spring Festival.

Maybe, as The Huffington Post had suggested, "If we were to learn from the experience of the past decade and half, the next development goals could be to create another China story, so to speak, which would bring humanity at the doorstep of ending extreme poverty for good. "



Because fighting poverty is one of the major tasks of China since the inception of the **PRC**.

Since 1978 China raised more than **750 million people** out of poverty. That alone amounted to **50% of the global poor population**.

An amazing achievement. While poverty alleviation is a task that many developed countries still are working on, including the USA, China instead vowed to end absolute poverty for the Centenary of the Communist Party of China (2021).

The national poverty line is not the same as the international poverty line – its requirements are actually higher.

### How does poverty alleviation work in China?


According to the Chinese government, a person can be considered as lifted out of poverty if all the following conditions are true:

1. Income is above the national poverty line of US\$3.20 per day. By comparison, international poverty line, set by the World Bank, is US\$1.90 per day. Both are adjusted by **Purchasing Power Parity** (2011);
2. Must live in a decent housing, with electricity, running water and a proper roof;
3. Any child should be going to school; illiterate adults need basic education too.

All the work that needs to be done to ensure these three points is on the shoulders of the poverty alleviation commissioners. They are members of the **Chinese Communist Party** who volunteer to go far away from their homes to help lift people out of poverty. As such, they need to do all kinds of tasks, from building modern houses to teaching basic hygiene.

As one may guess, it is also a dangerous job. **Almost 800 commissioners already lost their lives on duty**, but their results are incredible.

## Making sure people won't get poor again anymore

This is the most important part.

The Chinese approach against poverty has been effective especially thanks to **long term planning**. It is not enough to just provide **subsidies** to survive. Otherwise, once the subsidies are removed, people will just fall back into poverty again.

Chinese government believes that the basis for overcoming poverty is **education**.

For this reason, commissioners need to both ensure that **children go to school**, instead of working in the fields, for example. **Adults have to receive some basic schooling** as well.

In order to do that, they combine economic aid and support the adoption of new technologies, especially in farming. For example, schools provide lunch for children in the most impoverished areas. Some parents will send them to school only to have a **free meal**.

While COVID-19 is not exactly making things easier, China has very good chances of finishing the job right on time.

After that, it will be time to work on other categories of poor people: not in absolute poverty but, anyway, needing aid.

**To understand China's "secret," we must first look back to 1978, when the period of reform and opening up began.** Former Chinese leader Deng Xiaoping, the chief architect behind China's pro-market reforms, famously said, "Poverty is not socialism. Socialism means eliminating poverty."




Since the economic reforms were launched, China has witnessed unprecedented economic growth. Decades of rapid growth have served as the bedrock of the country's development, without which China's poverty alleviation miracle would not have been possible. That said, economic development alone was not enough to completely eliminate poverty.

**Ban Wei, deputy director of the Editor's Office of Xinhua News Agency, noted that the market is ultimately unable to deliver for those at the bottom.** In an address to the International Forum on Poverty Governance and Development Towards Modernization, Ban explained that many of China's rural poor were excluded from the market for living in remote locations.

**The market is a decisive and important resource-allocating factor, he said. "But market economics is based on efficiency and the market is unfriendly to those people in poverty."**

Robert Walker, a professor with the China Academy of Social Management at Beijing Normal University unpacked this point further. "The market will always favour the city because the city brings economies of scale," he told Beijing-based media China Focus.

**Under the leadership of President Xi, China waged an all-out war against poverty in late 2012.** Officials in Beijing rallied the 91 million Communist Party of China members, together with the private sector and members of the general public in pursuit of one central aim: The elimination of absolute poverty by 2020.



Local authorities largely took the lead over regional development, adopting a two-pronged approach that weaved together large-scale infrastructure projects with targeted poverty alleviation measures.

**Targeted poverty alleviation**, explains producer and writer Robert Lawrence Kuhn, means individualised attention to people in poverty.

Using a standardised criterion—which looked at income, opportunity, and access to basic necessities—all households below a certain threshold were assessed on whether they met the classification of "extreme poverty." The root causes of a family's poverty were then explored, and a customised plan was developed to ensure all received the support needed.

"Every poor family has its own file, a literal notebook, each with its own targeted plan to lift each above the line of absolute poverty," said Kuhn.

More than 250,000 teams were dispatched to offer on-the-ground support. In total, more than 3 million people were sent to the country's most remote villages as special commissioners for poverty relief.

**A common cause for many in poverty was found to be their location.** Take Tibet Autonomous Region for example. Tibet has historically been China's poorest region, mainly due to its remote and hostile environment. Known as the Roof of the World, the Qinghai-Tibet Plateau sits at an average elevation of 4,572 meters, and is surrounded by one of the most formidable mountain ranges on the planet.



Living in the remote highlands meant being cut off from high-quality public amenities, such as healthcare and education. It meant being unable to grow a variety of stable crops. And it also meant being restricted from engaging in trade and commerce.

**To alleviate this problem, local authorities launched an ambitious relocation program in 2013.** Following the example of other remote regions in China that incorporated relocation programs with a

mass-infrastructure drive, Tibet's most impoverished people were relocated to newly built communities with full access to essential services. More than 260,000 residents across the autonomous region took advantage of the scheme. Within six years, Tibet had shaken off absolute poverty.

In the hope that others can learn from its experience, China has committed to sharing its knowledge and methods with the developing world. It has made clear, however, that although China's methods worked for China, other countries must follow their own path in line with their unique challenges and environment.

**The key to China's development, then, is not any particular policy or method, but rather its political economy.** To understand China's success in poverty alleviation, researchers often refer to the five Ds. They are determined leadership, detailed blueprint, development-oriented, data-based governance, and decentralised delivery.



The determined leadership of President Xi and the Party has been noted by the UN secretary general and so bears not repeating. Its detailed blueprint refers to the plans sketched out by national and provincial-level leaders, some of which stretch for decades. Local leaders were largely responsible for the implementation and delivery of the detailed plans, and this is where decentralised delivery comes in.

Data-based governance refers to the more than 100 million files created on impoverished households. Development-oriented refers to the government's intervention in the market to promote more equitable growth.

With clear national priorities and using the power of the state to intervene, it is possible to organise the market in the people's interest while trying to control some of its disadvantages, Walker explained. The result is that "you can achieve the best of both worlds and benefit all sections of society," he added.

**China's secret then, if it can be called a "secret," lies in its creation of a powerful synergy between the state, market and society.** Socialism with Chinese characteristics has ultimately developed a new model of political economy with a proven track record in delivering high-quality development that is more fairly distributed across society.



That President Xi got it 'right' on his biggest policy choices since becoming President. In the West it is extremely popular to attack Xi because of the damage that China does to the environment, or the aggressive way in which China conducts geopolitical diplomacy, or on human rights issues. However, if you look on an inward basis he has lifted a staggering number of Chinese people out of poverty by focussing upon the poorest people in China rather than the wealthy. This is something which he receives virtually zero credit for doing, even though it is an absolutely staggering achievement. Admittedly: this didn't all happen under his watch, but the low hanging fruit was already won by the time he was President. He was left with the 'hard yards' of reducing the final balance to something close to zero. Getting the poverty from 50% to just about zero in two decades - staggering. If any other country did it, that would be Nobel prize material.

There are plenty of valid criticisms to be made of President Xi, but I don't think he gets nearly enough credit (or indeed any credit) for his signature policy success – almost single handedly ending Chinese poverty, and thereby cutting global poverty to a tiny fraction of what it once was.
