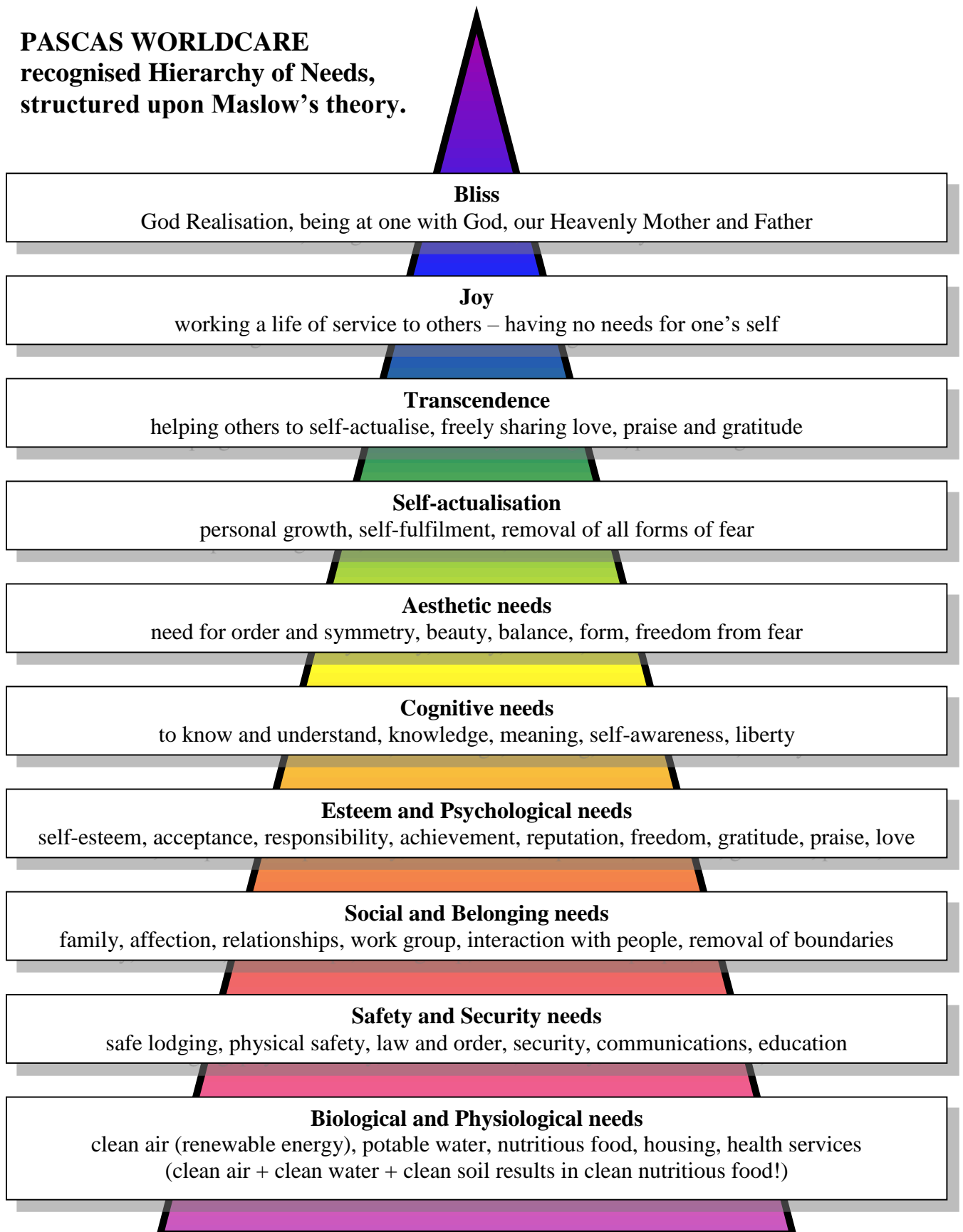

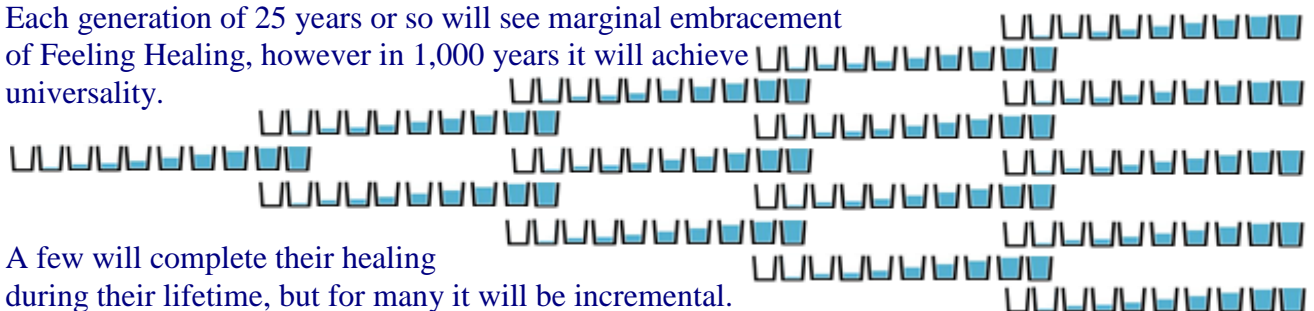

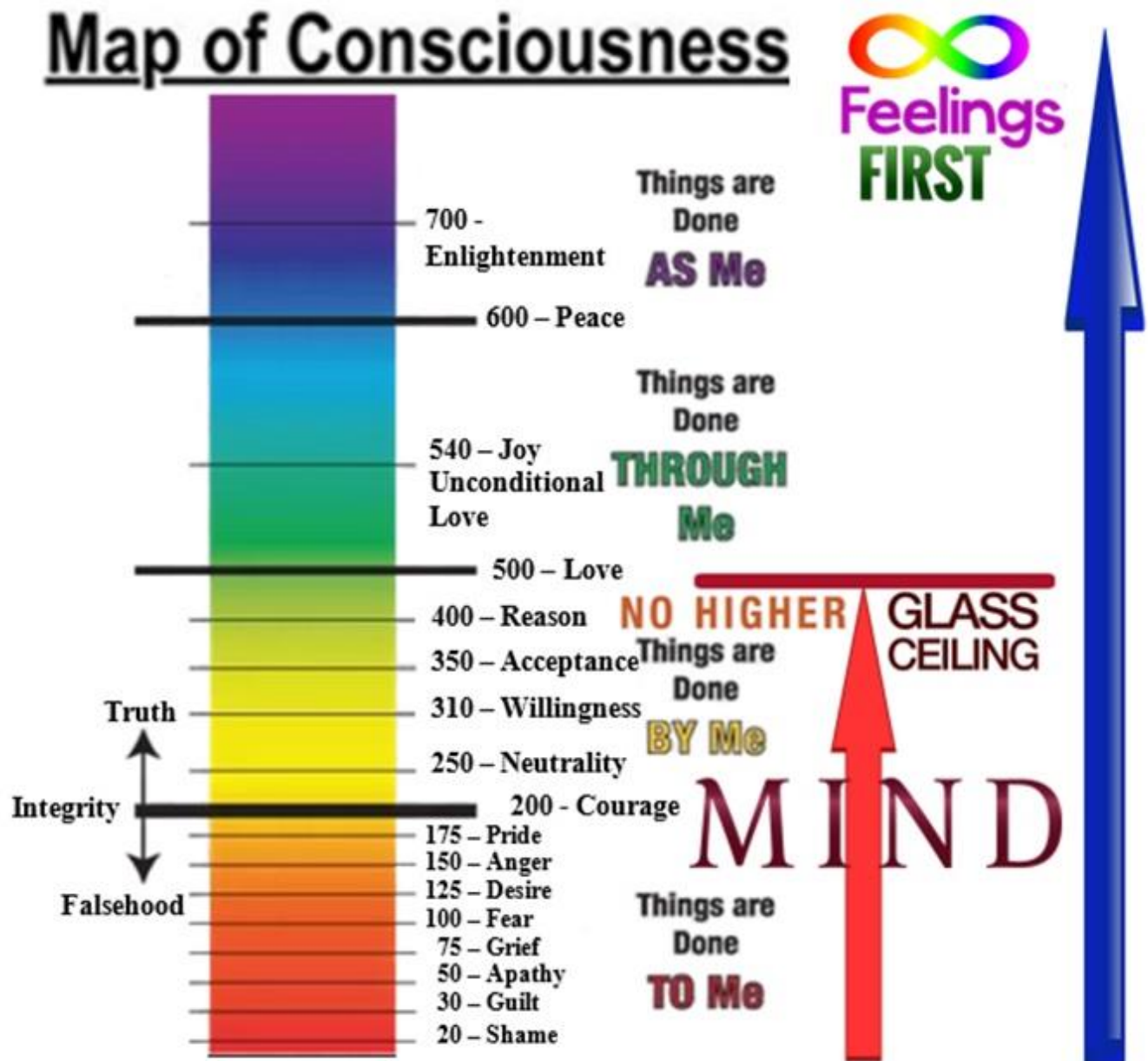

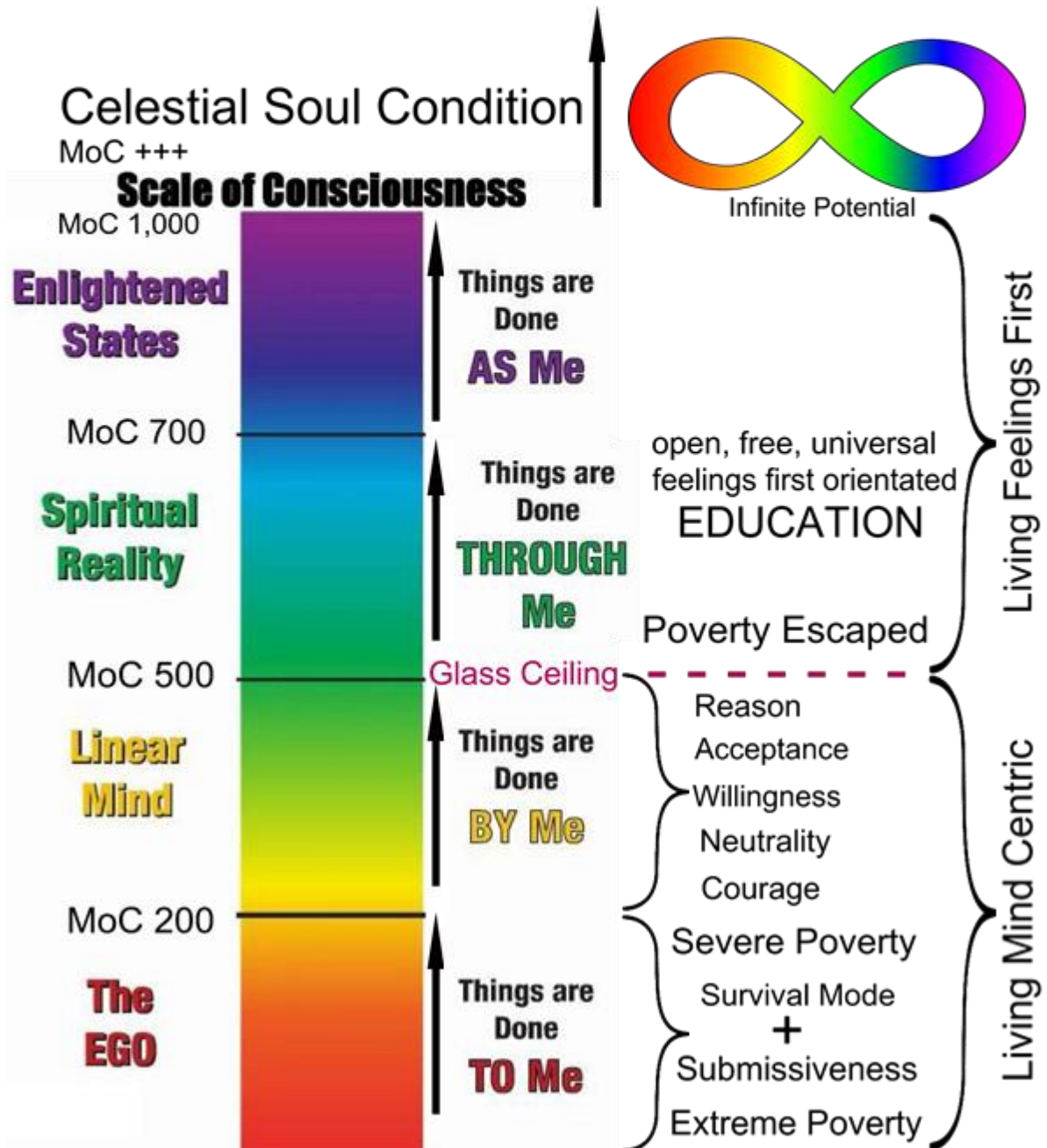

Map of the largest religion in every country



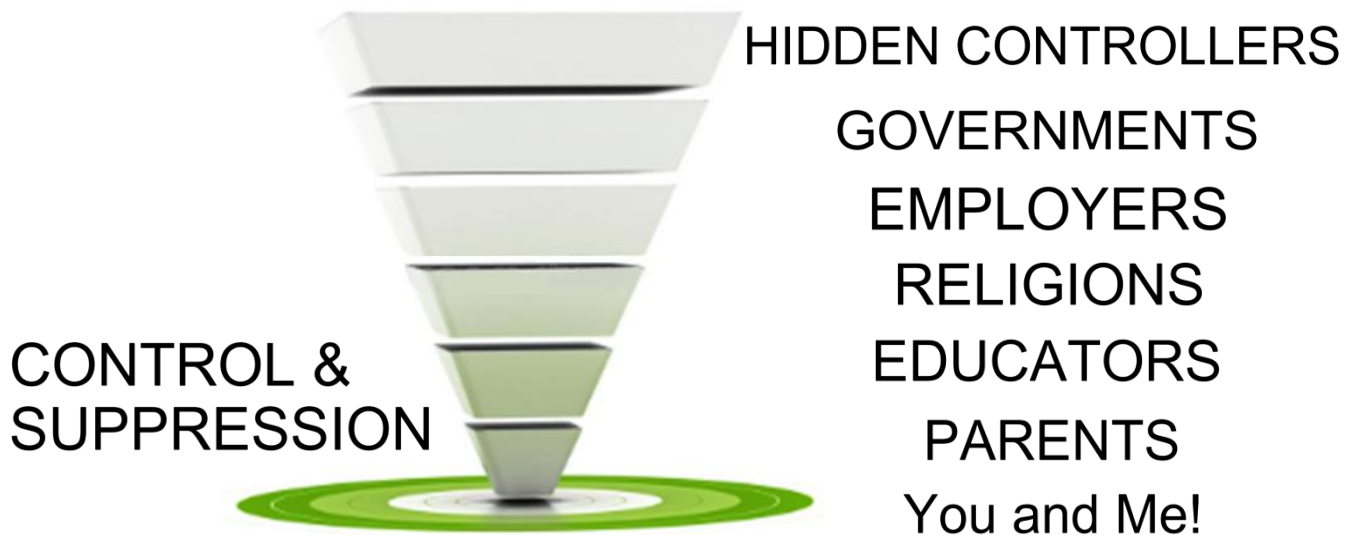

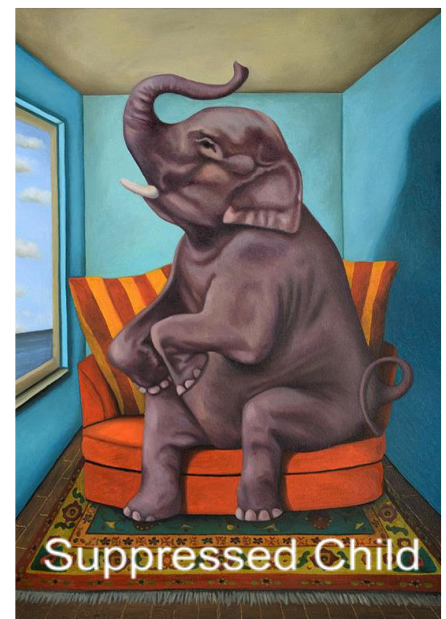

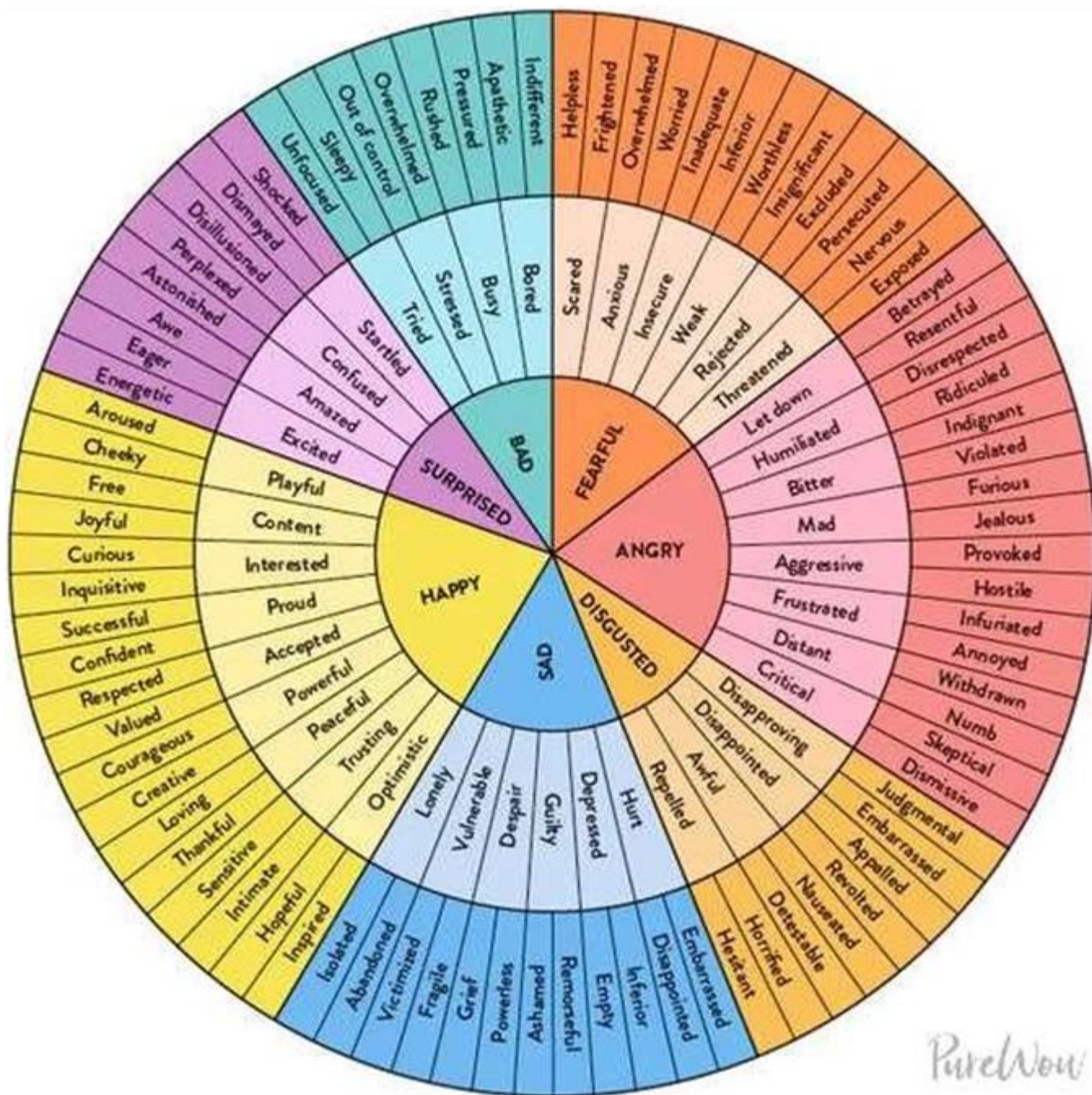

We are free to cry and express our pain here!

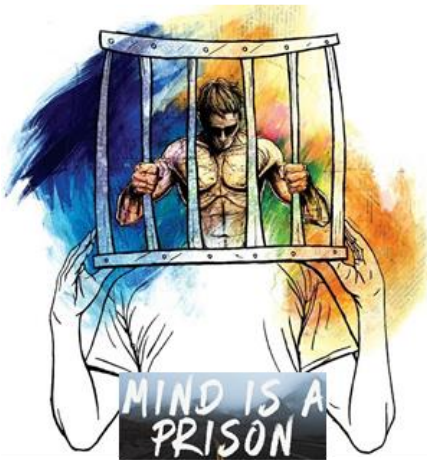
Adolescent children and young adults benefit greatly through exploring their feelings.

The introduction of new governmental and major corporate bonds into the financial markets, from then on, are released through around a dozen designated bond traders who are required to set aside about half of the ‘issue fees’ into accounts for global humanitarian projects and programs. The humanitarian fund releases were through the United Nations. As intermediaries pressed their commissions to ever higher percentages, reaching 30% of the allocations, fund releases stopped in 1993. The accumulation of bond trade fees has continued with ever increasing volumes. It is only now in 2025 that humanitarian releases are beginning again – but under new procedures. The United Nations has some 7,600 programs not yet funded from this massive pool of funds held in some 884 individual banks all over the world. The volumes of funds held are enormous.

The recommencement of humanitarian fund releases is referred to as Bretton Woods Mark II. This may also herald changes throughout the institutions referred to above. One being the removal of veto voting rights of the small number but powerful member countries. Further, the International Court of Justice, which has its seat in The Hague, may become a universal court recognised by all United Nations member countries.

Hong Kong Fund



Like the endeavours above, the Hong Kong Fund has taken several decades also to activate. This fund pool may only be around US\$10 trillion, a rather nominal amount compared to the Bretton Woods Mark II capabilities.

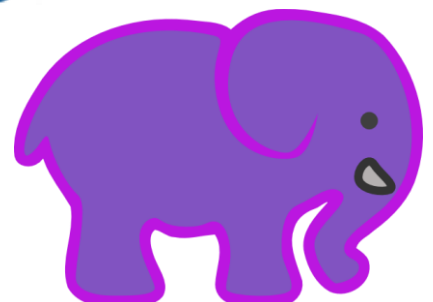

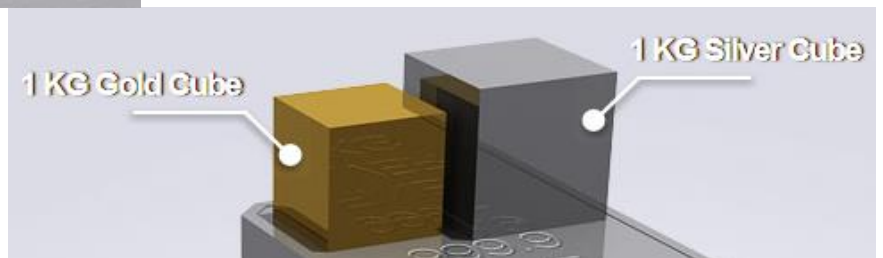
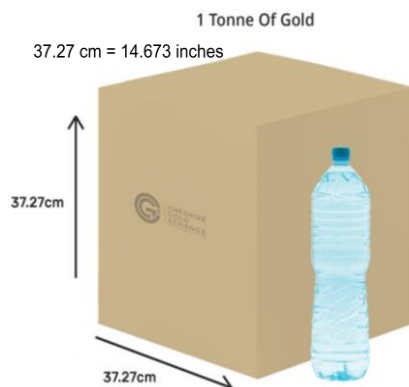

Larry Page:

The Mastermind behind Google

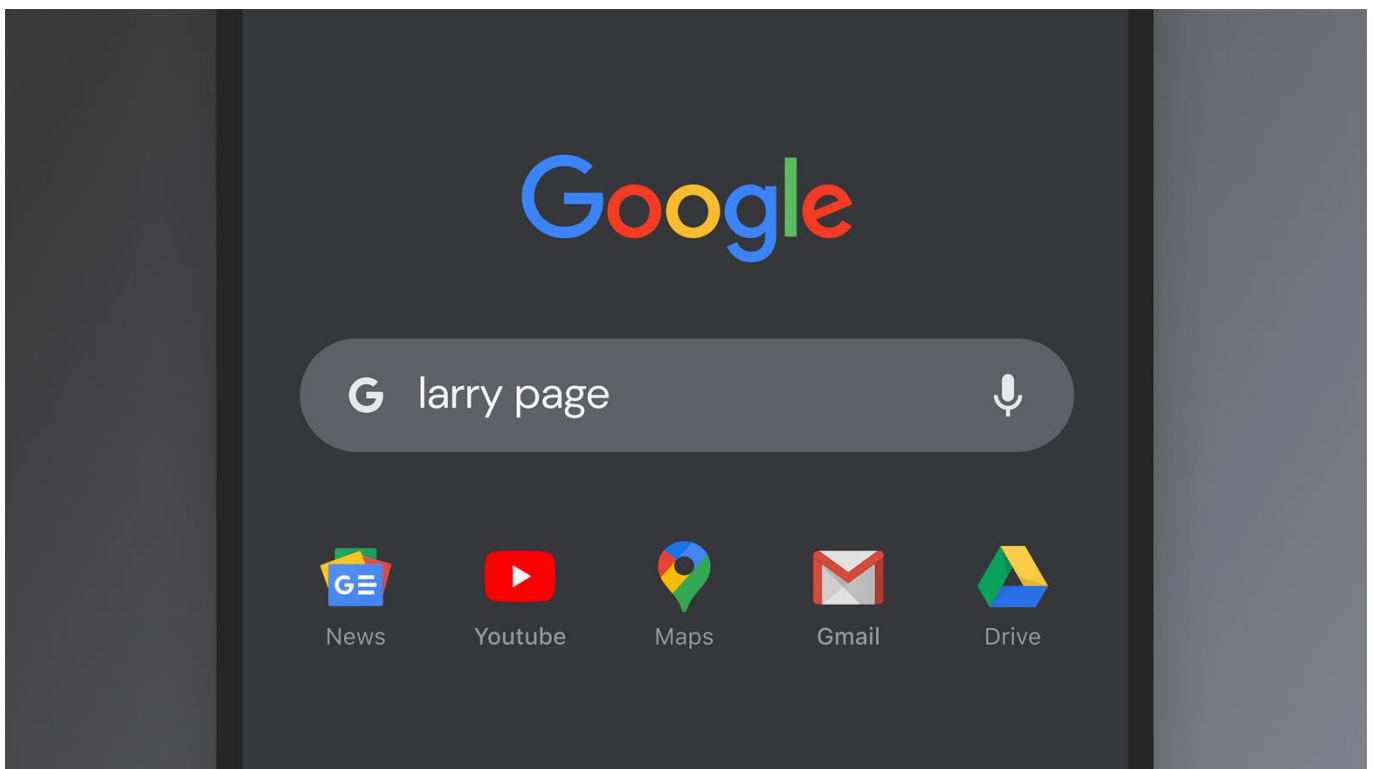

Larry Page is an American computer scientist and entrepreneur, renowned for co-founding Google with Sergey Brin in 1998 and for being one of the wealthiest individuals globally. Growing up in a household of computer science professionals – his father, a pioneer in computer science and artificial intelligence, and his mother, a computer programming instructor – fuelled his early passion for technology. This article explores the founding story of Google and examines Larry Page's pivotal role in creating Alphabet.

Who is Larry Page?

Larry Page, born March 26, 1973, in Michigan, is an American computer scientist and entrepreneur who co-founded Google with Sergey Brin in 1998. Page earned a computer engineering degree from the University of Michigan in 1995 before joining the doctoral program at Stanford University, where he first met Brin. Both were intrigued by the challenge of extracting meaningful information from the vast amounts of data on the Internet. While working in Page's dorm room at Stanford, they developed a new search engine technology. This technology utilised web users' ranking abilities by tracking the backlinks of websites – that is, the number of other pages linked to them.

Starting Google

To further develop their search engine, Page and Brin secured approximately US\$1 million in financing from investors, family, and friends. By September 1998, they founded Google, with Page at the helm as CEO. The nascent company was initially set up in Susan Wojcicki's garage in Menlo Park, California, which became their first office. This humble beginning in a garage epitomises the classic Silicon Valley start-up story. The following year, Google attracted US\$25 million in venture capital to capitalise on the enormous opportunity in search engine technology that was already then becoming evident. The name "Google" was inspired by the mathematical term "googol," indicative of their vision to organise a seemingly infinite amount of information on the web.

In 2001, Page transitioned to the role of President of Products, while Eric Schmidt assumed the position of CEO. Despite these changes, Page and Brin remained deeply engaged in Google's operations.

By 2004, the year of Google's IPO, the company was processing 200 million searches daily. Google was valued at US\$23 billion at its IPO, significantly surpassing expectations and firmly establishing it as one of the most valuable companies in the tech industry.

Creating Alphabet

In August 2015, Google underwent a major restructuring, leading to the creation of Alphabet. Following this, Google and other initiatives then became subsidiaries of Alphabet, with Larry Page serving as CEO of the conglomerate. Although Page stepped down as CEO in December 2019, allowing Sundar Pichai to take over the role, he remained actively involved as a member of the board of directors.

To understand the inception of Alphabet, it's crucial to revisit the roots of Google. Larry Page and Sergey Brin founded Google with the mission to organise the world's information and make it universally accessible and useful. The company, which started as a search engine, has at this stage evolved into one of the leading tech companies worldwide, having expanded into several advertising arms, cloud computing, hardware, and more.

The creation of Alphabet was driven by Larry Page's vision to restructure in order to foster greater transparency and agility for Google. This was a response to Google's rapid evolution into a more complex organisation with a diverse array of focus areas. The idea was to establish a new parent company, under which Google and other ventures would operate as independent entities. This structure aimed to create more focused incentives and enhance accountability for managers at the various subsidiaries.

Larry Page's Role and Vision

The Founding Story of Google

By the end of 1998, Google had indexed 60 million pages and was outperforming its competitors instantaneously. Initially hesitant to adopt an advertising-funded model, Page and Brin eventually embraced text-based advertisements, maintaining the simplicity and speed of their search engine while establishing a robust revenue stream.

Google's corporate ethos, formulated by the motto "Don't be evil," was highlighted already in their 2004 IPO prospectus. This ethos has underpinned Google's strategies and operations, influencing its approach to innovation and corporate responsibility.

Over the years, Google has expanded beyond its core search engine, developing products like Android, Gmail, and Google Cloud, as well as acquiring companies such as YouTube and Nest. Today, Google, along with its other subsidiaries, is housed under Alphabet Inc., which was established as the parent company in 2015.

Jeff Bezos' Early Investment in Google

Jeff Bezos, known for founding Amazon and being one of the wealthiest individuals in the world, made a significant investment in Google just months after its inception. In 1998, he invested US\$250,000, demonstrating faith in the vision of founders Larry Page and Sergey Brin. This decision was based not on detailed business plans but on Bezos's belief in the founders' potential. When Google went public in 2004, Bezos's shares were worth over US\$280 million. Although he no longer holds this stake, it highlights his ability to identify and support innovative tech start-ups early on.

The Creation of Alphabet

The idea behind the creation of Alphabet was to house Google's diverse ventures under one umbrella, allowing these ventures to operate independently with their own CEOs. This structure enabled Google to focus more on its core businesses, search and advertising, while other projects like Waymo (autonomous cars), Calico (biotech), and Verily (healthcare) could be managed more efficiently as separate entities. Alphabet's business model relies heavily on online advertising, with Google Search being a significant contributor to its revenue. In Q4 2023, Google Search accounted for 56% of Alphabet's total revenue.

Initially led by Page as CEO and Brin as President, the company later saw Sundar Pichai, the then CEO of Google, assume the role of Alphabet's CEO in December 2019. Both Page and Brin remain involved with Alphabet as board members and controlling shareholders.

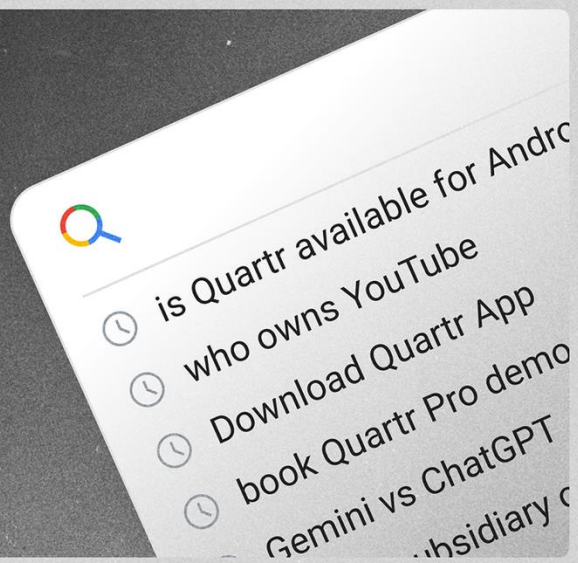

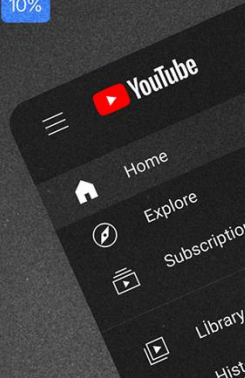

Management Style

Sergey Brin and Larry Page's mission was ambitious yet clear: to organise the world's information and make it universally accessible and useful. Remarkably, by the year 2000, Google had already indexed over one billion internet URLs, establishing itself as the most comprehensive search engine almost instantaneously.

The role of CEO was initially held by Larry Page, whose management style was distinctively unconventional. Page documented his early management principles, which included:

- Don't delegate. Do everything you can by yourself for it to go faster.
- Don't get involved if you're not adding value. Let people do their work and talk to each other.
- Value ideas more than age. Everyone, despite their age, deserves respect and cooperation.

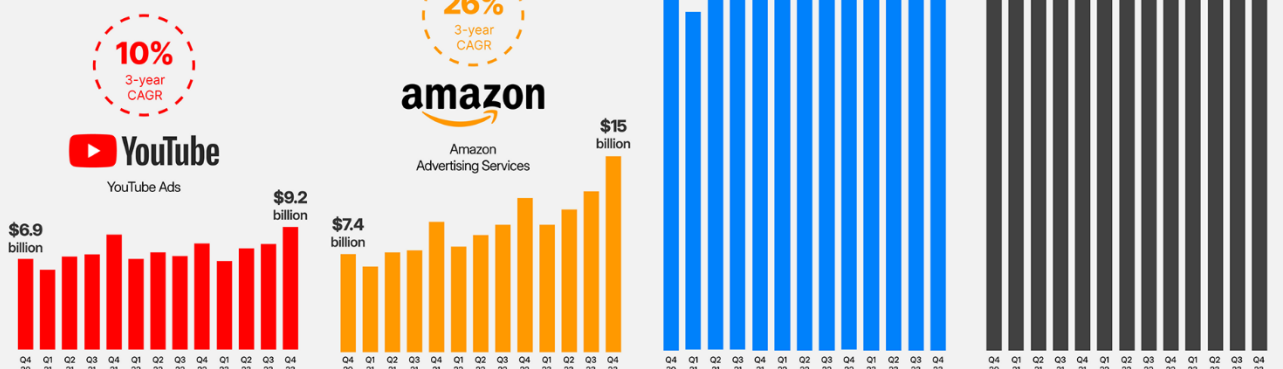

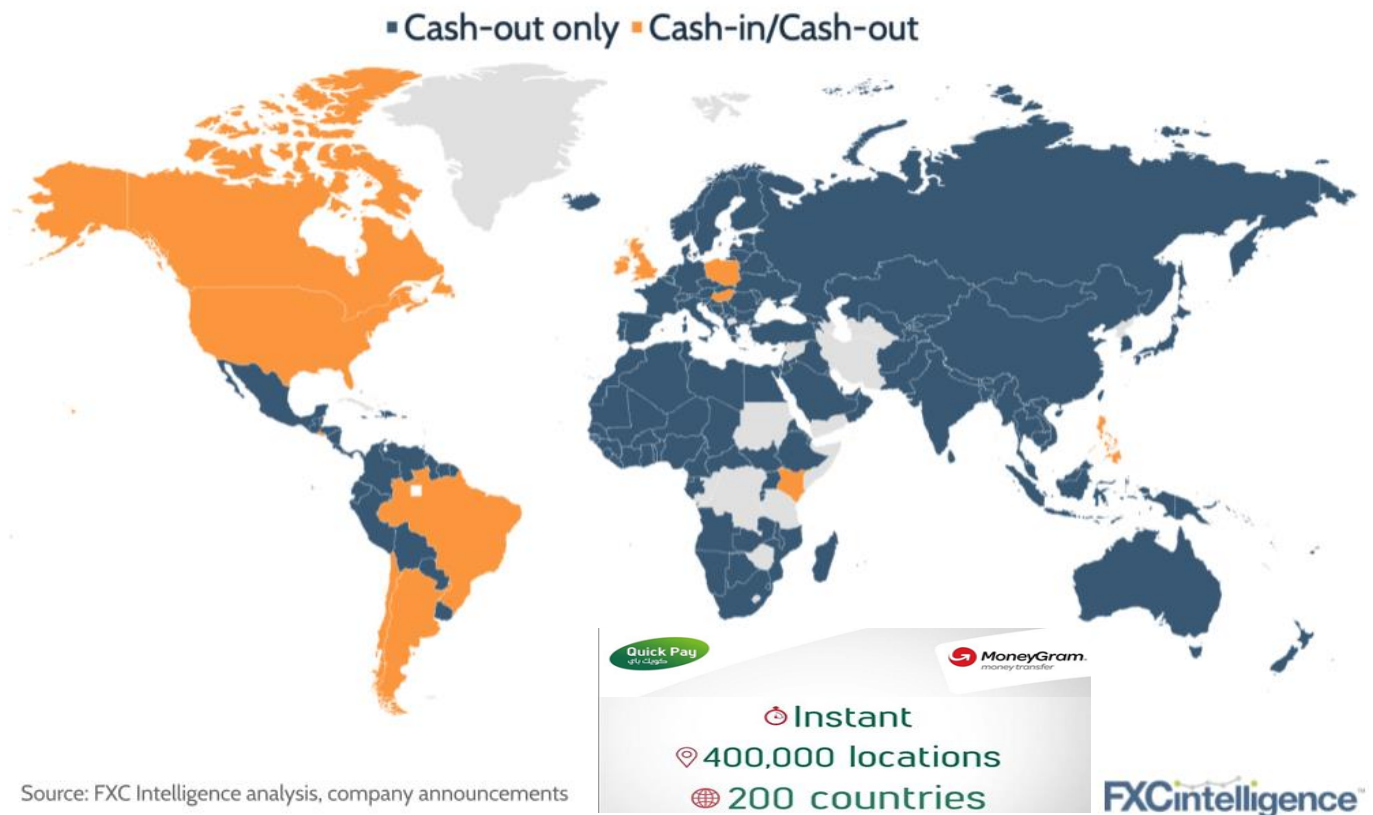

We've identified eight countries that have either banned crypto trading or restricted it severely, and we go over them below. However, there are also two countries that have swung the other way and have in fact made crypto legal tender. Let's take a look at all these polar opposites.

Where Is Crypto Illegal? A Full List of Countries

Crypto is illegal in China, Morocco, Egypt and more. Here, we'll go over the places that have declared war on crypto in some form or another.

Note that these countries have an outright ban on crypto; there are plenty more where crypto is restricted in some form or another with laws and regulations. Sometimes this is as simple as a ruling by a central bank that restricts crypto payments but allows trading; sometimes it takes the form of a limit on how much you can buy.

However, since many of these rules are open to interpretation, we've decided to leave them out of consideration. If you're curious about your own country — or one you're going to — and it's not on this list, make sure to run a Google search at the very least to get some more information.

1. China

China is the biggest country to ban all crypto on its shores. It started with a ban on local cryptocurrency exchanges in 2017 and slowly progressed to a complete ban on all things crypto-related in September 2021. *China Briefing* has all the details.

Unlike most countries on this list, China's reasoning for banning crypto has less to do with morals or fears of money laundering, and more with the central government's worries that the crypto shadow economy could harm economic development in China. It's a bit rich coming from a country suspected of fiddling with its economic metrics, but there you go.

2. Nepal

Nepal also banned crypto in September 2021. The Nepal Rastra Bank, the country's central bank, declared its use, mining and trade illegal. The reason for this drastic decision seems to be a fear of swindlers, which seems pretty fair — the number of NFT scams alone could fill a book.

3. Afghanistan

Afghanistan also banned crypto in September 2021. After the takeover of the country by the Taliban regime, the economy — unsurprisingly — collapsed. The only way to transact business with the outside world was using crypto, and a large black-market economy sprung up.

The Taliban, not fans of free markets in any way, responded by not just banning crypto, but also harshly penalising users and traders whenever they could. *The Intercept* has more if you're interested, but the upshot is that as long as the Taliban holds power there, Afghanistan isn't allowing crypto.

4. Bangladesh

Bangladesh joined the club a lot earlier than China or Nepal did, declaring all crypto-related activity illegal back in 2017. The government claimed that traffic in crypto would be in breach of the country's anti-money-laundering laws and even an anti-terrorism law.

5. Morocco

Morocco also banned crypto a few years ago, but is the only entry on this list that may actually reverse the decision at some point in 2023. A law has been drafted that would change virtual currencies' status in the North African kingdom, though it would still be a lot more strict than other countries' rules for crypto.

As for the original reasons for the ban, they again centre around the assumed criminality of crypto users, especially fears that financial institutions may not be able to identify streams of revenue. There are also concerns from scholars of Islamic law, some of whom contend crypto may infringe on the Muslim rules against usury.

6. Algeria

Algeria also has a total ban on crypto, though information is a lot more scarce. The best reports we found date from 2017 and state that a financial bill slated for 2018 would forbid virtual currency exchanges, trading and even holding any form of crypto.

7. Egypt

Egypt is the final North African country to forbid any form of crypto activity. The ban was enacted in 2020, with the central bank emphasising that crypto's value isn't tied to any tangible assets and only recognised national currencies are allowed to be traded in the country. 8. Bolivia

Our final entry of this list is also the first country to completely ban crypto. As early as 2014, Bolivian lawmakers were worried about the effect the trade was having on their country and its inhabitants. That said, crypto advocates are working hard to get the ban overturned.

Countries Where Crypto Is Legal Tender

Clearly, none of the above nations are fans of crypto. However, there are two countries that not only join the rest of the world in allowing people to buy and sell crypto, but have actually made Bitcoin legal tender.

El Salvador, a small Central American country, has made Bitcoin a fully fledged currency alongside its own fiat currency — the colón — as has the Central African Republic.

However, before crypto fans start crowing about how these two countries could be shining examples of the future of crypto, things are not looking good. According to *Bloomberg*, El Salvador's experiment with making Bitcoin legal currency is "failing miserably," for example, with the biggest news coming out of the country being an economic crisis and a political crackdown.

There is less current news about the CAR, but just a week after the news of the adoption of cryptocurrency in the struggling nation broke, *Reuters* already expressed serious doubt about its viability. We have a feeling that, in this case, no news does not mean good news.

Final Thoughts

Oddly enough, despite all the issues with Bitcoin, only a handful of countries ban cryptocurrency outright. Plenty more regulate it strongly, including not allowing it to be used for payments. Seeing the example of El Salvador and the CAR, though, you can't help but wonder whether stricter countries don't have it right.

On the other hand, a few countries are considering issuing stablecoins — crypto assets tied to their own currency that could be used to facilitate electronic payments.

Called CBDCs, or central bank digital currencies, this could be a new way for crypto to go mainstream. That said, only the U.K. has made anything resembling concrete steps to implementing CBDCs thus far.

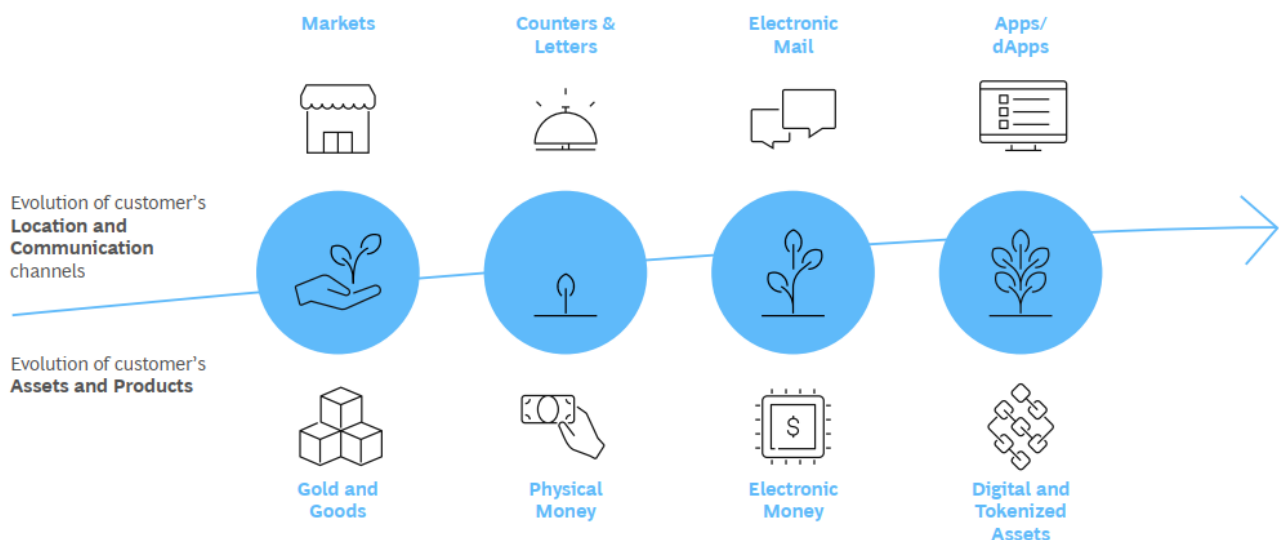

in USD trillion

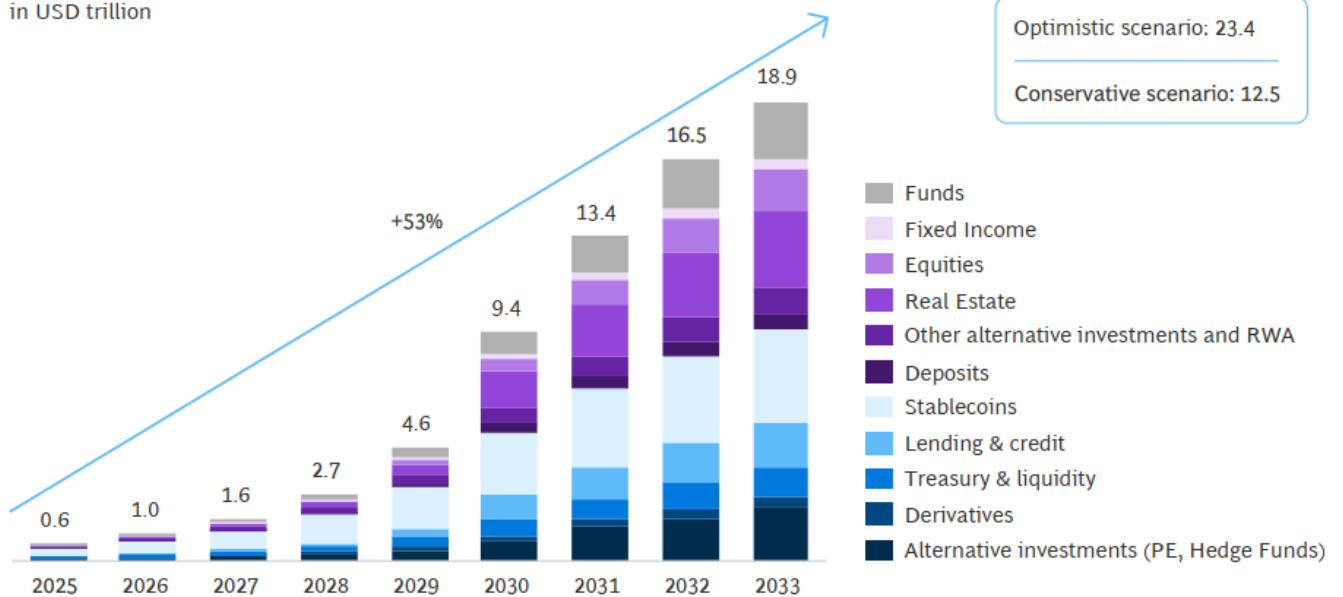

The Twin Flywheels of Tokenization Market Adoption

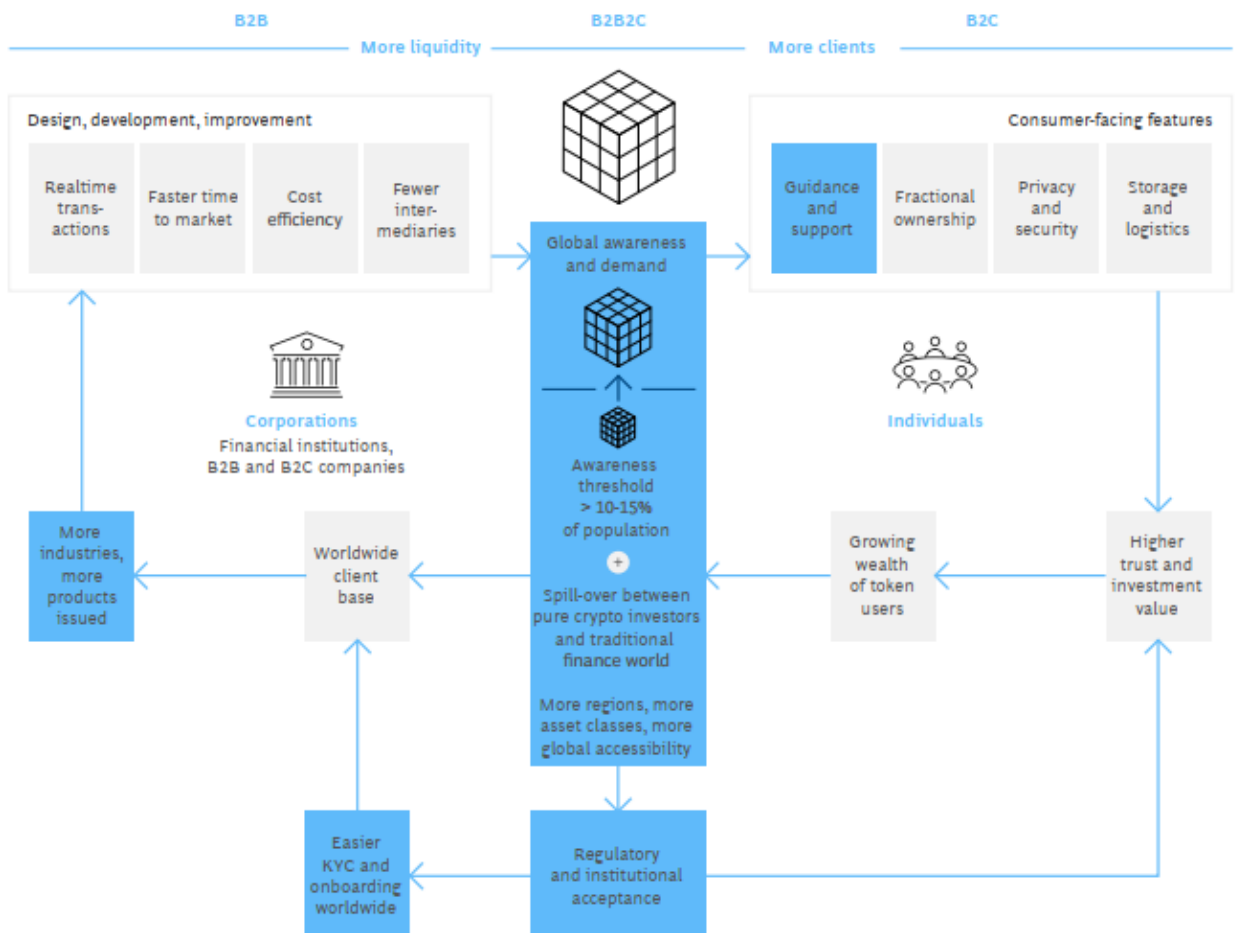


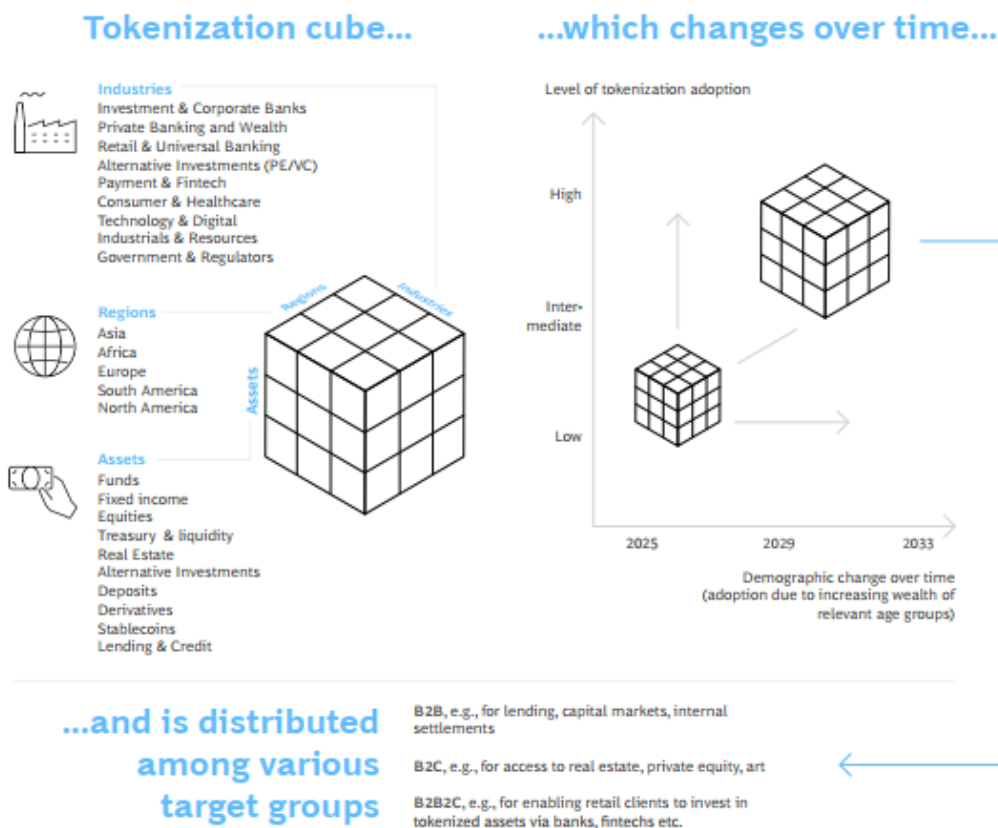

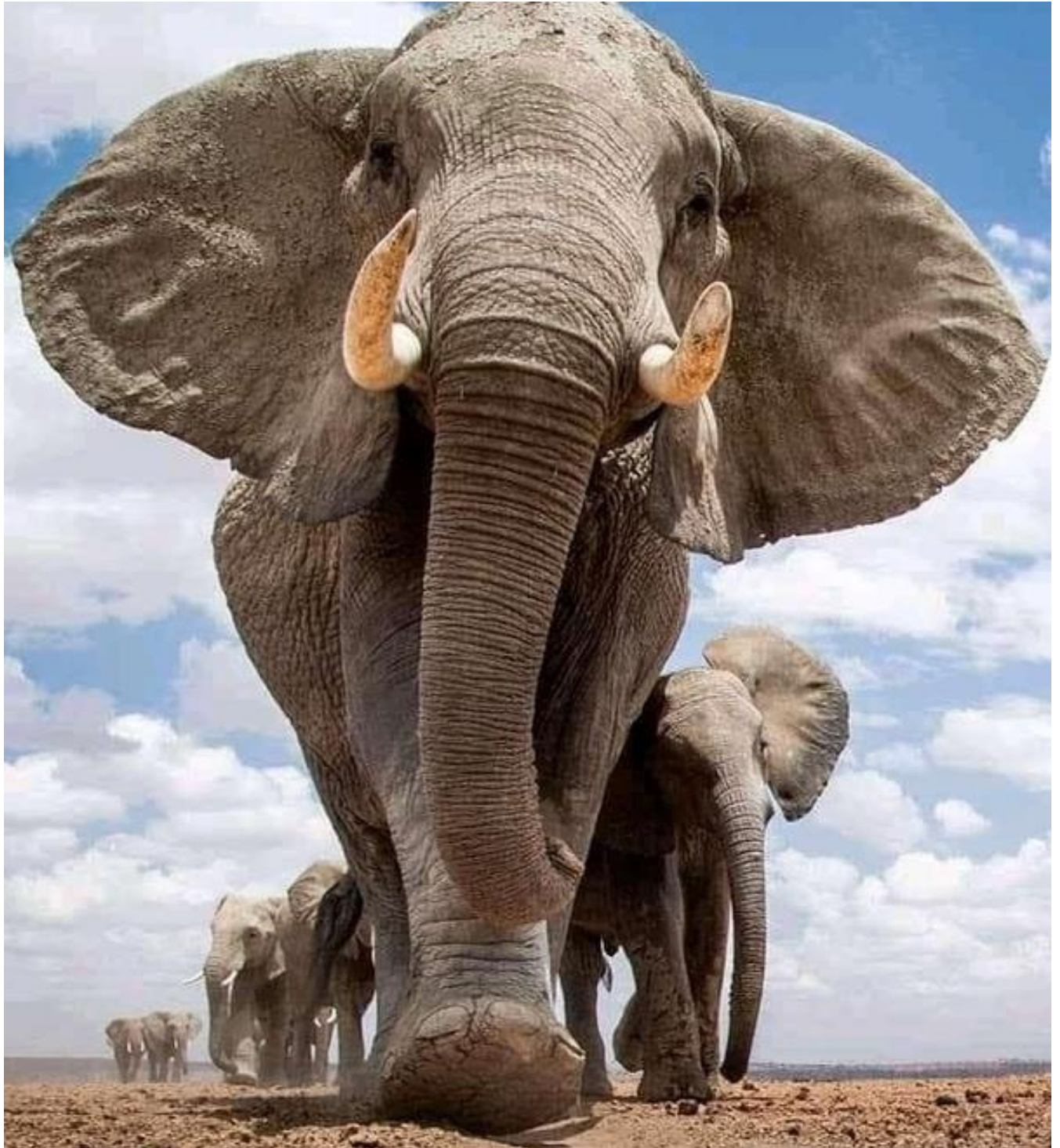
